 Wisconsin Building Code Section 1019.3, item #4. Exit Access Stairways
 The project uses and exit access stairway to connect levels P-2, P-1, 1, and level 2 in the parking garage. Because the exit access stairway serves 4 levels an 18" draft curtain and closely spaced sprinklers are required.

2. The rule being petitioned cannot be entirely satisfied because:

During the design phase the building foundation was raised to avoid a high water table. Because we lost a level of parking, a mezzanine was used and the floor to floor height was condensed, causing a ceiling height issue with an 18" draft curtain. We are requesting a 16" deep draft curtain.

The following alternatives and supporting information are proposed as a means of providing an equivalent degree of health, safety, and welfare as addressed by the rule:

Because the use of an 18" deep draft curtain would project below the minumum		
ceiling height of 80", a 16" deep draft curtain is proposed. The sprinkler design team		
has discussed this issue with Bill Sullivan, Fire Marshal, City of Madison. Bill has		
confirmed that he would support the use of a 16" deep draft curtain for this exit access		
stairway. The location of this stairway is located in a Type I-A structure with a very		
limited fuel load due to the concrete construction of the parking garage.
