I learned that the proposed units have been reduced to around 1,100 from the previously proposed plan iterations. Only plans for MORE homes (for more Madisonians in need of safe, permanently affordable, sustainable housing) should be encouraged.

I applaud the inclusion of permanently affordable housing through an option to the Madison Area Community Land Trust (MACLT). I am a current resident of MACLT and I believe that we need more housing under the land trust model to provide more opportunities for families to buy affordable homes in Madison. The Land Trust is a remarkable non-profit in that it also supports and educates its homeowners on how to care for their home and the land for the long-term.

MACLT has assisted us with refinancing and repairing our home so that we can afford to remain living in our home. I believe MACLT has about 70 homes now. Growing that number in Madison will benefit the entire Community because access to affordable housing coupled with the the Land Trust's support has also provided our family with TIME (my husband and I do not need second jobs) to accomplish goals like volunteering, voting, and civic engagement - such as writing letters of support to the Common Council.

Our organization is excited about the opportunity to provide Madison with more permanently affordable homeownership opportunities.

As a Madison resident I am in full support of this development as the Voit farm site is a perfect site for new and diverse housing for the community. I believe the development is well thought out and presents a structured use of the space which balances an influx of new residents with the existing infrastructure. The diversity of housing options is a major benefit to the community and fits the neighborhood aesthetic as well as the greater needs of housing in Madison. If anything I would like to see more housing units at the site but from the review of the proposal I believe in its current state it would be a wonderful addition to the community.

The other project I would like to submit my support for is the development of 6610-6706 Old Sauk Road. As a west side resident I am incredibly excited about more infill neighborhood housing. Through my review of the development proposal and understanding of the current neighborhood I believe that this project fits well within the location it is posed. I hope to see more projects of a similar nature throughout the city and while neighboring feedback can often present loads of problems in need of solving I encourage plan commission members to consider what is being lost by not approving a project. This complex will provide 138 homes to Madison residents in an area that previously only could house 2 families.

Dear Plan Commissioners,

You have a lot of exciting items on your June 10 agenda. In particular, I want to express support for both the Tiny Home Village and the Starkweather Plat. I live near/between both these locations, and I look forward to how both of these projects will bring more neighbors into the neighborhood, particularly those who are struggling the most with finding housing. I wish my neighborhood were doing even more, and I believe we could, if we had more zoning flexibility--not the contiguous swathes of single-unit-only we have today.

Recognizing the housing crisis we're in, I'm also very supportive of the proposed added housing on Wilson St, Braxton Pl, Whitney Way, and Old Sauk Rd.

It's a shame that neighbors have already bullied the owner of the Old Sauk Rd property into scaling down their plans. We really can't afford to let an entire neighborhood just opt out of addressing this crisis, and if this doesn't get approved, I don't see how else that neighborhood could conceivably create 138 additional housing units. I hope that you'll consider the 138+ future residents, whose voices are not included in this process.

I just wish Stone House Development would include commercial space! This part of Old Sauk Rd is short on this kind of amenity, and while it could be that adding density will spur the creation of commercial space nearby in future, including commercial space as part of this project could also help win over the neighbors, by making the neighborhood more self-sufficient and walkable.

My name is Angie Alcorta and I am writing today in support of the proposed Starkweather Plat at the Voit property. I applaud the inclusion of permanently affordable housing through an option to the Madison Area Community Land Trust. As a current resident of MACLT, I believe we need more housing under this model to provide more opportunities for families and singles to buy affordable homes in Madison.

I have been working for 6 years as a housing case manager and recently doing intake calls for families seeking emergency shelter at the family shelter in town. I triage each situation and provide resources and referrals. I work with families that are in their darkest moments facing housing insecurity. In the time I have spent helping others get into housing, I felt I was stuck in the vicious cycle of renting and living with roommates that stole from me, making for a constant feeling of unease at home where I should have been able to recuperate from the world. I was also paying nearly 2/3'rds of my income in rent alone and using resources like food pantries to make ends meet.

I make a humble \$23 an hour and am a single BIPOC LGBT cis female. Even though I work full time helping other families get into housing I could not even consider owning my own home as my salary is not enough to afford rental, let alone a single family home in the Madison area.

In 2019 I was able to purchase my first home on the East side of Madison near the proposed Starkweather Plat at the Voit property. I plan to live in this home for the rest of my life. MACLT has made it possible for me to have a piece of the American Dream that I thought I would never be able to have. I finally have peace in my home and can save money to do things like pay off my car, take a vacation, have a garden, pets in the home, basic things that should be in reach to everyone.

MACLT has drastically improved my overall well being and quality of life for the better. Getting involved with MACLT was the best thing I have done for my mental and physical well being. I encourage the Plan Commission and Common Council to allow MACLT to acquire this land to make affordable housing accessible for more low income Madisonians.
