Bartillon Shelter Percent for Art Plan - [Legistar File 78514](#)

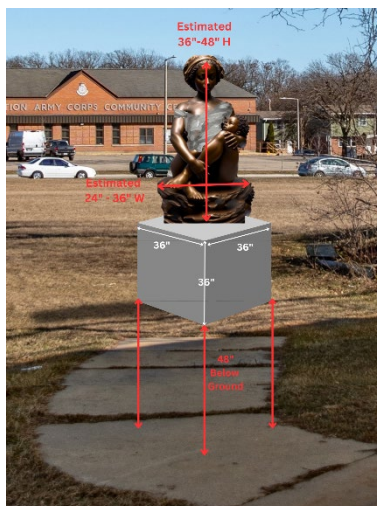
1904 Bartillon Dr, District 12



- Madison Arts & Engineering staff consulted with Lillian Sizemore on a design for a façade mosaic.
- The proposed mosaic locations were included in the Bartillon Shelter proposal that was approved by Urban Design Commission on Wednesday, February 14, 2024.
- Staff will develop an RFQ for a mosaic artist to design and develop mosaics to fit the proposed locations. Applications will be reviewed by MAC.

Starkweather Creek Bike Path at E Washington Avenue, District 12



- A final design was recommended by MAC on May 14, 2024, after review of three proposed designs and community feedback
- Staff are working with the artist and an engineering team to design the foundation, which needs to be presented to the Board of Public Works before the resolution can be voted on by Council.
- Once the resolution is approved, we will enter into an agreement for fabrication & delivery.
- Anticipated installation Fall 2024.

Madison Municipal Building (MMB) Art Exhibition

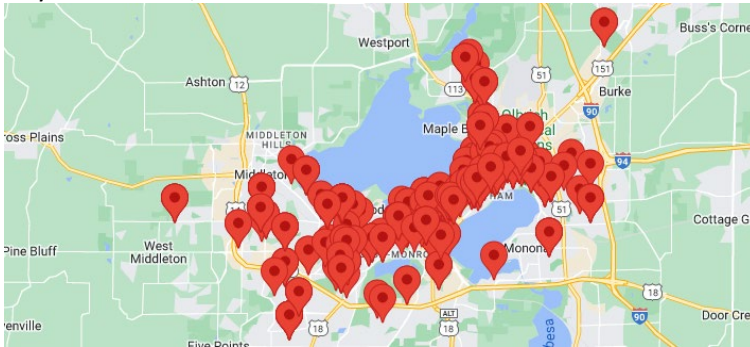
215 Martin Luther King Jr Blvd., District 4

- We will soon install works by Meghan Johnson and Pat Dillon’s Cultural Connections.
- On Monday, June 17, artist Angela Johnson will teach a family artmaking workshop at Lisa Link Peace Park as part of the Flock to State initiative. Some of the artwork produced that evening will likely be featured in the public lobby of the Housing office in MMB.
- We will likely schedule an open house in Fall, 2024.

- Installation schedule was delayed due to rusted and deteriorating siding.
- MAC reviewed updated proposal on April 3, 2024, to approve the artist work with staff and the design team to modify the project to meet the new façade, in keeping the original project intent and materials.
- Artist was paid an additional \$9,975 in April 2024 to work on updated designs.
- Installation has been rescheduled to spring/summer 2026.
- Once the agreement is complete and timeline is set, a press release will be published.

- MAC juried this year's exhibition and selected 5 sculptures from 33 submissions.
- Selected artworks include Drip Edge by Craig Snyder, Renaissance by John Hallett, Flight by Hilde DeBruyne, Letting Go by Judd Nelson, and Structure by Jon Kamrath.
- Exhibition on view through October

Conservation Update

Annie Stewart Memorial Fountain

586 Wingra Street, District 13



- February 2023: CSOS conservation report is completed.
- March 2023: Community survey was completed (1,393 responses).
- July 2023: Neighborhood meeting. Consensus - the sculpture and base should be removed, conserved, and stored until a purpose-built structure can be built, ideally Vilas park to retain history.
- Spring 2024: Proposal to host the fountain at Neighborhood House Community Center which is being redeveloped. They could store the work after conserved, until there is a permanent site.
- June 25, 2024 at 7 pm: Neighborhood meeting scheduled to discuss proposal and next steps.
