SUMMARY:

At its meeting of October 19, 2005, the Urban Design Commission **GRANTED FINAL APPROVAL** of a PUD(GDP-SIP) for a convenience store with gasoline sales and carwash at 401 North Third Street, in Urban Design District No. 4. Christopher Thiel, with SAA, reviewed the changes since the initial approval. The under canopy light levels have been reduced, the length of the employee parking stalls has been reduced, and the development has been moved forward 15 feet on the site. He stated that, per discussions with Traffic Engineering and Planning staff, the driveway on Third Street will be located as far from the intersection as possible. He stated that the project does not include a green roof or solar canopy, but they are still exploring the potential.

ACTION:

On a motion by Geer, seconded by March, the Urban Design Commission **GRANTED FINAL APPROVAL** of a PUD(GDP-SIP) for a convenience store with gasoline sales and carwash at 401 North Third Street, in Urban Design District No. 4. The motion was passed on a vote of (7-1-1) with Host-Jablonski voting no and Barnett abstaining.

After the Commission acts on an application, individual Commissioners rate the overall design on a scale of 1 to 10, including any changes required by the Commission. The ratings are for information only. They are not used to decide whether the project should be approved. The scale is 1 = complete failure; 2 = critically bad; 3 = very poor; 4 = poor; 5 = fair; 6 = good; 7 = very good; 8 = excellent; 9 = superior; and 10 = outstanding. The overall ratings for this project are 4, 6, 6, 7, 7 and 7.5, with 3 abstentions from the rating process.
