Dear Sharon:

Pursuant to the provisions of Sec. 28.12(9)(g) of the Madison General Ordinances of the City of Madison and Sec. 62.23(7)(d)2m of the Wisconsin Statutes, I am submitting petitions against the proposed rezoning of 702 N. Midvale Blvd., which is currently zoned PUD-GDP-SIP and is proposed to be zoned to Amended PUD-GDP-SIP.

In support of said protest, I am submitting the following petitions:

- 1. The first set of petitions is signed by **owners** of land directly opposite the area to be rezoned extending 100 feet from the street frontage of such opposite land. Said petitions contain 37 signatures.
