We are writing in support of the Midvale Heights residents who are working to ensure community input in redevelopment plans for Midvale Plaza. A combined steering committee from Westmorland and Midvale Heights has been working for over a year to gather citizen input on this project and convey that input to the developer and owner of Midvale Plaza. As you may know, Midvale Plaza lies in Westmorland, but is directly across the street from the Midvale Heights neighborhood.

The committee has gathered more than 700 signatures in support of guidelines for the project that reduce the scale and density of the proposed development while including the library, retail, condos, and apartments, as proposed by the developer. We believe that these alternative guidelines meet the letter and the spirit of the city's Comprehensive Plan, providing for up to 90 residential units on a 3.5-acre parcel where there are currently none. These guidelines also advocate for the current tenants of the Plaza; the developer's proposal makes it difficult if not impossible for all current retailers to stay in business at the Plaza while the project is being completed.

In addition to supporting infill, the Comprehensive Plan also recommends significant neighborhood input for redevelopment plans. We ask that you listen to members of the steering committee and weigh their views carefully before you vote on this matter at the Common Council's July 18<sup>th</sup> meeting.


