DRAFTER'S ANALYSIS: This ordinance modifies the salary of the unrepresented position of Assistant City Attorney to be consistent with those represented by the MCAA bargaining unit, as adopted and confirmed in their Labor Agreement with the City of Madison for the period of January 1, 2006 to December 31, 2007.

The Common Council of the City of Madison do hereby ordain as follows:

Subdivision (b) of Subsection (1) entitled "Basic Salary Schedules By Compensation Groups" of Section 3.54 entitled "Compensation Plan" of the Madison General Ordinances is amended by amending therein the following:

"(b) Effective January 1, 2006, the following nonrepresented administrative, professional, and supervisory positions shall be compensated in accordance with the salary schedule, classifications, and salary ranges herein designated; provided, however, that salary designations applicable to individual range steps indicated with a single asterisk (*) shall be effective for persons compensated pursuant to such range steps on and after June 18, 2006, and that those indicated with a double asterisk (**) shall be effective for persons compensated pursuant to such range steps on and after June 18, 2006, and that those indicated with a double asterisk (**) shall be effective for persons compensated pursuant to such range steps on and after June 11, 2006, and that, when present, those indicated with a triple asterisk (**) shall be effective for persons compensated pursuant to such range steps on and after June 11, 2007.
