- b. The square footage shall not exceed 40% of the signable area

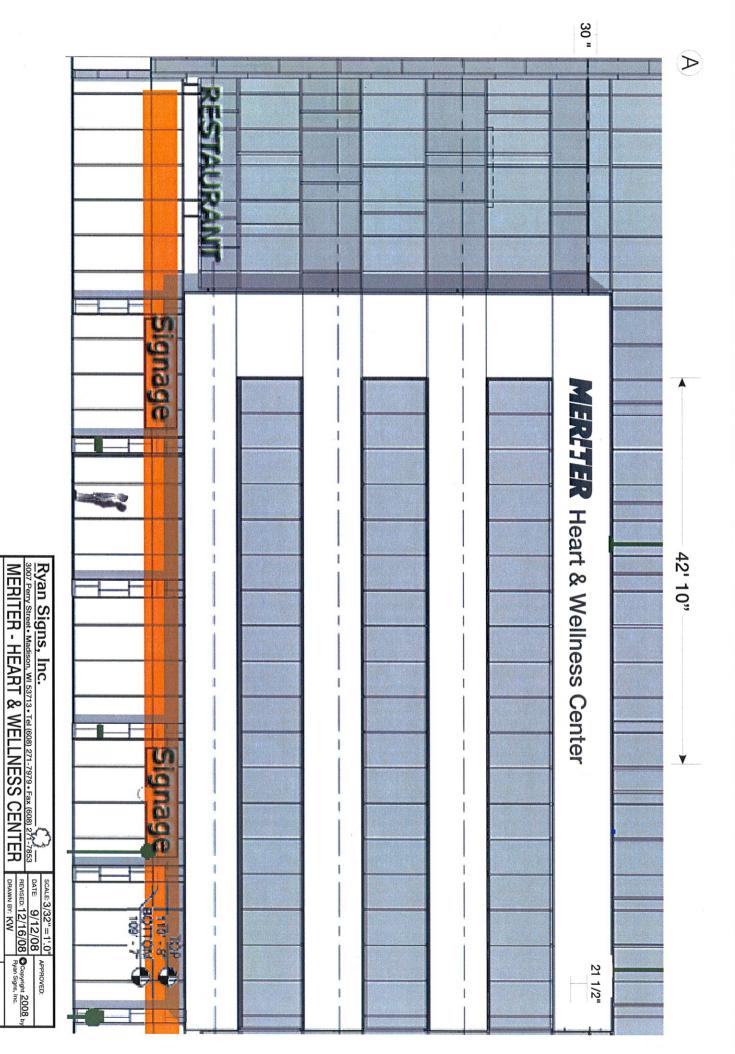
2. Specifications
