SUMMARY:

At its meeting of February 18, 2009, the Urban Design Commission **GRANTED FINAL APPROVAL** of a comprehensive design review (continuation) at 2501 and 2601 West Beltline Highway. Mary Beth Growney Selene, with Ryan Signs, Inc., stated that a condition of the previously approved comprehensive design review was that the design of secondary tenant signage be approved by the Commission. This request is for the approval of the Meriter Wellness Center sign. She reviewed the specifics of the design, stating that the maximum height of the letters will be 24 inches, and that the letters will have aluminum faces and be backlit.

Melissa Huggins and John Eisenhauer registered in support.

ACTION:

On a motion by Harrington, seconded by Weber, the Urban Design Commission **GRANTED FINAL APPROVAL** of a comprehensive design review (continuation) at 2501 and 2601 West Beltline Highway.
