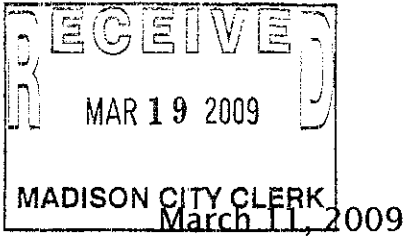

Dear Mayor Cieslewicz:

It may seem hard to believe that in our fast paced mobile society there are Glendale residents who have lived in the neighborhood for over fifty years. On Camden Road alone thirty to forty five year home owner occupants have been the backbone of stability during almost a decade of difficult and deteriorating living conditions. Some of the families are original homeowners whose adult kids keep telling them to move because things are better elsewhere and some live on Camden Road because they like their house. Their commitment to Madison should not go unnoticed as they have worked diligently to maintain one of their biggest assets.

Wednesday night Camden Road residents will address the Board of Public Works committee due to the cost estimates they received in the mail last week-end for proposed curb, gutter and sidewalk. February 19, 2009 a proposal was presented by Engineering to Camden Road residents at Glendale School and as early as Feb 21st thirty one property owners received their \$4000-\$8000 cost estimates. While this may not be a large project in the scope of routine city business, to the property owners on Camden the cost and timing of this potential project could not appear at a more inopportune time

I am wondering what kind of fiduciary responsibility the City of Madison feels toward its residents given the current national, regional and local economic climate. Our residents find the cost a big burden, they are not happy to absorb it and with dignity they do not want to qualify for a low income loan program to pay for it. The work of Glendale police liaison Dan McFarlane has been terrific in the neighborhood and he has worked tirelessly with our neighbors to regain the quality of life they desire and once knew on their street. This unexpected bill is not what they anticipated as part of the long journey to recoup the area.

Aesthetic improvements between Camden Road and the Stoughton Road commercial district have yet to come to fruition despite the approximate quarter million dollars spent studying the corridor during SRRP. There are still less expensive improvements that could be made with regard to junk cars on property, too many vehicles both on/off properties and property curb appeal issues such as overflowing garbage barrels in the front of homes. We have worked diligently with the City, Madison Metro, MGE and others to rid bad behavior, graffiti and other negative impacts from the area. Curb, gutter and sidewalks will probably not cure the root cause of many of the existing problems.

We hope that the City of Madison will re evaluate the timing of this project given current economic uncertainty. The fiscally responsible and socially conscious Glendale Neighborhood residents who reside on Camden Road continue to keep this part of Madison a great place to live. Thank you for your time and consideration.
