My grandparents 40 acres of land in this neighborhood over 25 years ago. As my grandmother is currently 92, I find myself serving as trustee for this land.

Our land is in Phase B. I have no objections to the approval of Phase A, in fact I believe it to be a reasonable request by the property owner. The lands in the Shadywood Neighborhood all belong to the same geographic area, but perhaps don't really constitute a "neighborhood" in that the goals and land use plans for these areas are very different. Few would argue that much of the land in Phases B & C is not suited for the same type of development as Phase A. And so adopting only part of the plan, while unusual may be appropriate in this case to give us all more time to seek the right mix of uses that would suit the beauty and unique features of the land in Phases B&C.
