- 2. EXCEPTED FROM THE DESCRIPTIONS OF THE FOREGOING EASEMENT AREAS ARE THE AREAS OF THE BUILDINGS AND A 0.50 FOOT BUFFER ALONG THE FACE OF SAID BUILDINGS, AS CONSTRUCTED AS OF AUGUST 5, 2009.
- 3. THE REFERENCE LINES OF THE FOREGOING EASEMENT AREAS ARE INTENDED TO BE THE CENTERLINES OF ATYPICAL 20-FOOT WIDE EASEMENTS.
