Comments related to providing TIF money for the Edgewater Hotel redevelopment:

I strongly **OPPOSE** the Edgewater redevelopment as it is currently proposed, but DO wish to see reinvestment in this property. No TIF money should be approved until the following issues are satisfactorily addressed:

- The height of the 16-story tower is completely out of scale with the surrounding historic properties. Height should be reduced to fall within the Capitol sightline requirements and to better fit with the surrounding structures.
- The design of the tower is completely undistinguished and shows no sensitivity to or connection with the Moderne style of the original 1948 Edgewater building. This is an exceptional site and it demands exceptional architecture – not generic corporate schlock.
- Traffic, parking, and service (truck delivery) concerns of the neighbors have not been fully addressed to date.
