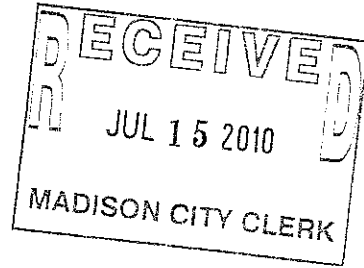


PETITION FOR DETACHMENT

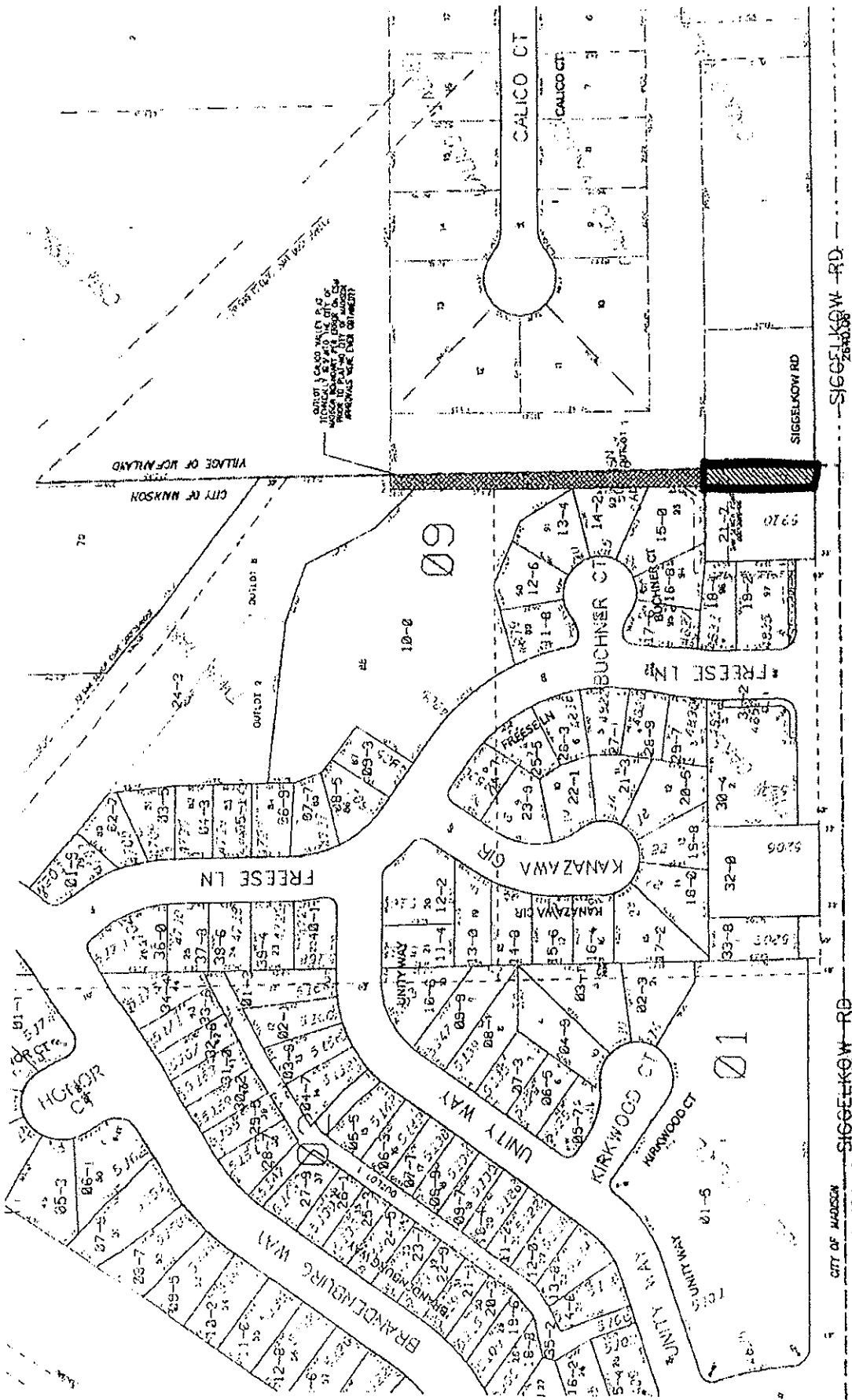

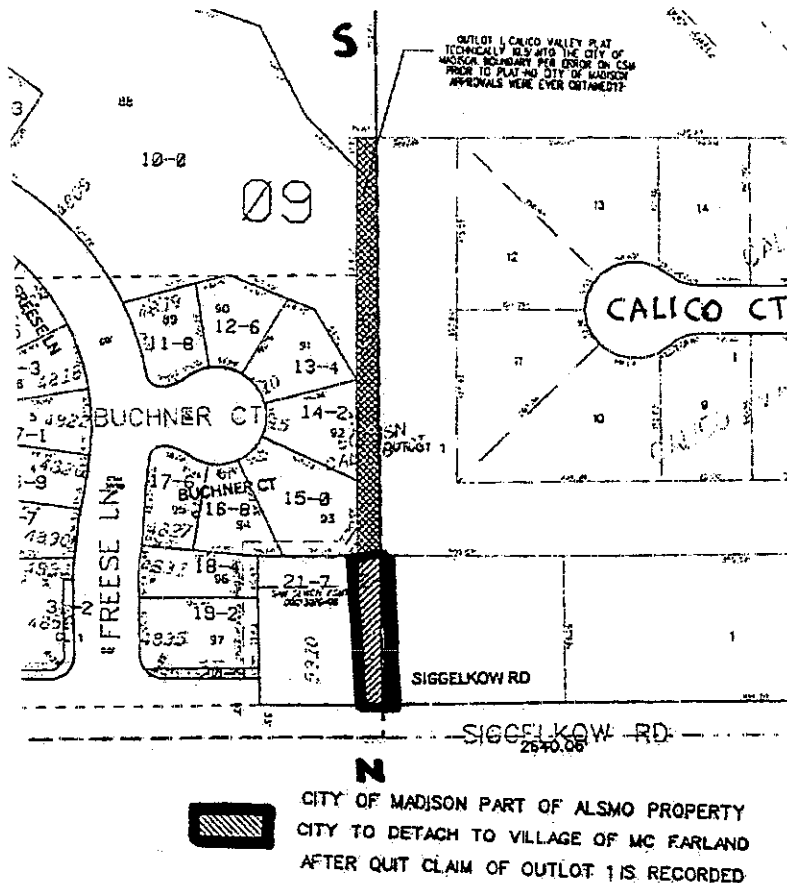
