I know the silo is an inspiration piece for you and I admit to being intriqued by it. Aside from concerns about the silo, it looks like staff would recommend issuing a CoA.

Moving the silo to the rear of the house by the new addition has de-emphasized some of its overpowering 'farm' qualities. The form and materials will still be visible from the street but offer less of a complete view. I think repurposing the silo adds an unusual postmodern twist to a historic farmhouse now surrounded by the urban grid of 19-20th C houses and streets in one of the oldest neighborhoods in the city.

I support of your proposal. I support moving the house toward Baldwin and staff comments which include lowering the height of the roof line of the new addition.
