Dear ALRC Members,

l am writing about items #40 and #41 on your June 16 agenda, representing the Central Business Improvement District (BID).

Item #40: Creating new Section 38.12 and renumbering current Section 38.12 to Section 38.13 to prohibit the sale of alcohol to habitually intoxicated persons; amending Section 24.02 relating to disorderly conduct in a public place while under the influence of alcohol; and amending Sec. 1.08(3) of the Madison General Ordinances to establish a bail deposit for a violation.

The BID Board recognizes that problematic and disorderly behavior by habitually intoxicated persons is concentrated in the central business district. Problematic behaviors of habitually intoxicated persons in the district are among the top concerns of BID merchants and property owners. These behaviors have negative impacts for the individuals involved and others; compromise safety and economic vitality in the downtown; and consume an inordinate amount of public and private resources (i.e., police time) that might better be allocated to solutions such as treatment. The BID Board supports alcohol policies that are closely targeted to address problematic drinking, and which are developed in collaboration with business and industry representatives. The BID Board support the general concept of this ordinance to create a ban list that includes specifically defined individuals and prohibits their being sold alcohol.

Item #41: Amending Section 38.06(8) of the Madison General Ordinances to prohibit the drinking of alcohol by licensees and employees of a licensed retail alcohol establishment while working in the establishment. http://legistar.cityofmadison.com/detailreport/matter.aspx?key=18278

The BID Board continues to <u>oppose</u> this ordinance in its current form. Its scope is too broad and it has unintended consequences. It is not targeted to address problem drinking. The problem the ordinance addresses is unclear (if there is one). This ordinance needs more stakeholder discussion and input before being voted on. The BID Board would be happy to serve as a resource and referral committee.
