The City of Madison is proposing to improve Joylynne Drive from Pflaum Road to Tompkins Drive and Douglas Trail from Herro Lane to east of Joylynne Drive. Sidewalk will be installed on Turner Avenue from Pflaum Road to the bus stop. In addition, storm sewer will be installed, on Pflaum Road, from Joylynne Drive to Camden Road. This project involves special assessments to owners of property along the project. You are being sent this letter to notify you of the public hearing before the Board of Public Works at the above referenced date, time & location. City Engineering will be making a short presentation at the meeting, followed by the public hearing. Attached to this letter is a schedule of assessments that contains the estimated cost for each property on the project.

Scope of Work

This project includes spot repairs to the sanitary sewer main, the installation or replacement of storm sewer, replacement of the existing water main and laterals, the construction of concrete curb and gutter and an asphalt pavement. In addition, sidewalk will be installed along the east side of Joylynne Drive from Pflaum Road to Tompkins Drive and on the west side of Joylynne Drive from Pflaum Road to Douglas Trail. Numerous trees will need to be need removed, from within the right-of-way, to facilitate the sidewalk construction. If the project is approved, construction will start in late April 2011 and be completed in late summer 2011.

Street Improvements

The proposed street improvements include the construction of concrete curb and gutter, concrete drive aprons and an asphalt pavement. Joylynne Drive and Douglas Trail will be constructed at a width of thirty-two (32) feet, approximately the same width as the existing streets.

Sidewalk will be installed along both sides of Joylynne Drive between Pflaum Road and Douglas Trail and on the east side between Douglas Trail and Tompkins Drive. The City's standard is for a 5' wide sidewalk placed I' from the edge of the right-ofway. Due to the location of the proposed sidewalk and curbs, the required excavation and the locations of the existing trees, it will be necessary to remove several trees. Each tree has been reviewed by the City Forester to determine the existing condition of the tree and the impact that the proposed construction will have on the tree. Following the completion of the plans, and prior to the start of construction, the trees will be evaluated again. If a tree can be saved by shifting the location of the sidewalk, partially onto private property through the acquisition of a permanent limited easement, the City will contact the property owner. If the property owner is willing to grant an easement, at no cost to the City, steps will be taken to revise the proposed sidewalk location in order to protect the tree.

Drive Aprons

The drive apron, the area between the sidewalk and curb, will be constructed with concrete. The aprons are proposed to be the same width as the driveway, at the property line, and will be four feet wider at the curb. Prior to construction, property owners will receive a copy of a Residential Driveway Opening Request form which allows them to change the size of the proposed apron, provided that is complies with the Madison General Ordinances. The signed form authorizes the construction of the larger apron and the resulting larger assessment.

Impact on Trees and Landscaping

The City Forestry crews will be trimming the terrace trees, which may remain, in preparation for the roadway construction. Many of the trees will be removed during construction, but the City will attempt to save as many trees as possible.

Please note that construction will also have an impact on landscape features in the right-of-way. With the nature of this work, property owners should anticipate that the entire right-of-way, will be disturbed. Therefore, any plantings or special landscaping or decorative features that an owner wishes to save from damage should be removed from the right-of-way prior to the start of construction. The right-of-way extends to a point approximately fourteen (14) feet from the edge of the existing pavement.

Sanitary Sewer Main and Lateral Replacement

The sanitary sewer main is not being replaced, but there will be limited repair work. Sanitary sewer laterals are owned by the property owners and it is their responsibility to maintain them. However, upon request, the City is willing to replace sanitary sewer laterals within the public right-of-way (the length of sewer lateral between the sanitary sewer main and the property line). The City would share the cost of replacing laterals within the right-of-way. The City would pay 75% and the property owner would be assesses the remaining 25% of the cost. The City only participates in the cost of the sanitary sewer lateral replacement when the replacements coincides with a street reconstruction project. This offer will not be available to property owners upon completion of the project. Replacement of the sanitary sewer lateral from the property line to your home would be solely your responsibility and will not be coordinated or funded by the City. Storm Sewer

Storm sewer main, leads, and inlets will be installed or replaced as part of this project. New larger capacity storm sewer will be installed beneath the street on Joylynne Drive to replace the existing backyard storm sewer located behind the homes on the east side of Joylynne Drive. The backyard storm sewer will be abandoned in place. The storm sewer along Douglas Trail will be upgraded and connected to the new storm sewer along Joylynne Drive. The storm sewer main will be extended along Pflaum Road to connect the storm sewer pipe installed on Camden Road in 2010 to the new storm sewer to be installed along Joylynne Drive. This work is not assessed to property owners. Lisa Coleman is the storm sewer designer for this project; you may contact her at 266-4093 or lcoleman@cityofmadison.com.

Water Main

The existing water main and laterals, within the right-of-way, will be replaced with this project. This work is not assessed to the property owners. If you have questions related to the water main replacement, you may contact Kelly Miess at 261-9640 or kmiess@madisonwater.org.

Assessments

A special assessment is a special charge for work that the City is planning to complete. The attached schedule of assessments shows an estimate of the property owners' share of the project based upon the City's assessment policy. When the project is bid, and work is complete, a final assessment will be calculated based on work actually performed. The final assessment is payable in one lump sum or over a period of 8 years, with 2.5% interest charged on the unpaid balance.

The City and the property owners adjoining the project will share the cost of the street improvements. The property owner is responsible for the cost of the sidewalk, curb and gutter, drive aprons and a cost equal to four (4) feet of the roadway. The attached Schedule of Assessments shows a breakdown of costs for each of the assessable items and the total estimated cost to be assessed to each adjacent property owner.
