Thank you for taking the time to <u>fully</u> read this email. I apologize for its length, however, it is all pertinent information.

I have never met anyone in the Wells family, however, based on Mr. Wells' presentation in the written form, I am confident that he is a well-respected adult who knows how to make good business investments. He is **investing** in a business venture, as well as investing in the future success of his son. He should be commended not tossed aside! He is excited to assist his son to move on from his past, only to have a roadblock thrown up in the 11th hour.

I do, however, know Joseph J. Johnson. I've known him his entire life. I have watched Joe excel as a student, falter as a teenager/young man (while *still* excelling as a student – taking university courses), and grow into a mature adult man. Yes, he is convicted of a felony. Notably, he was <u>released early</u> from his probation as his probation officer also saw the maturity, intelligence, and drive Joe had for redirecting his life. I think, however, it would be prudent to consider and give weight to the other facts presented here and presented in person by Debra and Dale Wells: the obvious investment strategy the Wells have that allows them ability to further **invest** in a business venture, the Wells' character references as to their son Jason, and the word of a Mother in Eau Claire, Wisconsin. We DO know these young men and we will always have faith in them. For the Wells to take an additional step to financially invest in a business endeavor, in which Jason and Joe would likely be employed, well that goes beyond the love of a parent towards his child. It is also an investment toward the Wells' financial stability.
