Position Statement on Agenda Item 20 - Change of Licensed Premise for Wal-Mart Stores

The Dane County Coalition to Reduce Alcohol Abuse (DCCRAA) strongly opposes the change of licensed premise for Wal-Mart Stores, specifically the store at 7202 Watts Rd currently applying. To address alcohol abuse, studies show we must reduce accessibility to alcohol and moving alcohol from behind the check-out counters to the store floor does the exact opposite.

Furthermore, the request to increase the floor space for alcohol from four sections to 27 is alarming, unnecessary and counterproductive to reducing alcohol abuse. There is no reason to have this product within arm's reach of our young people.
