
## **Application for Change of Licensed Premise**

Detailed floor plans (no larger than 8 ½ x 14) must accompany this form, or the request will not be presented to the ALRC. Applicants must appear before the ALRC.
Please contact City Zoning (MMB LL-100, 608-266-4560). A Conditional Use Permit may be required. There is a fee for the Conditional Use Permit.
