> I have lived at 505 Muir Drive since 1982. I live approximately 2-3 blocks south of the proposed Museum storage facility on Troy Drive at Harper.

>

> I would like to voice my concerns about the selection of this site for this building. I am not in support of this location for several reasons.

>

> #1- This is a very quiet, residential neighborhood.

>

> #2- A building of this size and magnitude would overwhelm the neighborhood.

>

> #3- I don't think that this building would fit in with Troy Garden next door.

>

> #4- A building like this, with basically no windows, could be placed anywhere, not in a nature conservancy.

>

> #5- I would rather leave the land to the wildlife than build such a big building at this location. (Nesting Great Horned Owls, Sandhill Cranes, Deer, Fox, Bluebirds, Wild Turkeys, Goldfinches, frogs, to name just a few, along with many endangered species of wildflowers including trillium, dog-toothed violets, giant solomon seal, false solomon seal, dutchman's breeches, and Jack-in-the-pulpits, etc.)

> #6- The North Lake Mendota Neighborhood Association should have been included in the planning process.

>

> #7- I am very fearful that if this project proceeds in the manner that it has been set forth, I worry about the future preservation of ALL of the state owned conservancy land adjacent to Mendota Mental Health Property. The land that I am most concerned about includes Governor's Island, Lakeshore paths, and woods, along with the world's largest collection of Indian Mounds. This area is a State and National Treasure that deserves more careful preservation.
