## **Text of Legislative File 23234**

#### **Fiscal Note**

The projected cost for the remainder of 2011 is approximately \$1,125 (or \$1,600 including fringe benefits) and is available in the Monona Terrace budget through management of salary savings. The estimated annualized cost is \$5,300 (or \$7,500 including fringe benefits).

### **Title**
