Letter of intent for an amendment to the approved Comprehensive Design Plan at Arbor Gate Development for Meriter Health Services, Inc.

Dear Mr. Martin;

On behalf of Meriter Health Services, Inc., we are writing to request an amendment to the Comprehensive Design Plan for the Arbor Gate development. As you may be aware, Meriter has an existing sign for the Meriter Wellness Center in the building located at 2501 W. Beltline Hwy. As of January 1, 2012, we will occupy space in the 2601 W. Beltline Hwy. building, formerly occupied by Wisconsin Heart. The new entity will be called Meriter Wisconsin Heart.

Our submittal includes two amendment requests:

- To allow for our corporate logo and color to be used on new signage for Meriter
 Wisconsin Heart on the west elevation of the west building at 2601 W. Beltline Hwy, and
- 2. To allow for our corporate logo and color to be used for updated signage for Meriter Wellness Center (or similar name now under consideration) on the north elevation of the east building at 2501 W. Beltline Hwy.

We believe our proposed amendment will allow our signage to be an attribute to the entire sign package and will fit well with the building architecture. We have included images of the proposed signage for your review (attachments 1 and 2).

Our proposed amendment represents a minor change in that it allows for our logo to be used in conjunction with our corporate color. Our request is for our two signs only. We are not seeking to amend the Comprehensive Design Plan for the entire Arbor Gate Development.

The faces of each of the "Meriter" representations will be displayed in PMS #287 (Blue) per attachment 3. The sides of the letters will be painted to match the originally approved Pewter color. The "Wisconsin Heart" and "Wellness Center" (or similar) will be displayed in Black with the originally approved Pewter for the sidewalls of the letters. (The color Black has been approved in a previous amendment to the Comprehensive Design Plan.)

The Meriter "Blue" is part of our overall branding effort. Our request of you is to simply allow us to utilize our complete logo element and create consistency in our signage at Arbor Gate.
