SUBJECT: 2011 Fourth Quarter and Year-End Traffic Enforcement Activity Report

The information provided in this document represents the Madison Police Department's traffic enforcement activity for the fourth quarter of 2011 and the year.

In the fourth quarter of 2011, the Madison Police Department issued 4,933 traffic citations (3,295 citations for hazardous violations and 1,638 citations for non-hazardous violations). Of this total, 1,575 citations (1,110 hazardous and 465 non-hazardous) were issued by the Traffic Enforcement Safety Team (T.E.S.T.). These numbers reflect a 2% decrease in the total number of citations issued department wide and a 4% increase in the issuance of overall citations by the Traffic Enforcement Safety Team, when compared to fourth quarter data from 2010. Included in the this data are 1,506 speeding citations issued department-wide during the fourth quarter of 2011, which reflects a 5% increase when compared to 1,435 citations issued in the fourth quarter of 2010.

The total number of traffic citations issued by the Madison Police Department in 2011 was 21,844, as compared to 25,624 citations issued in 2010. This represents a decrease of 15% from the total number of citations issued in 2010. The number of citations issued for hazardous violations in 2011 decreased approximately 19% from 2010(14,504 from 18,004), and the number of citations issued for non-hazardous violations decreased approximately 4% (7,340 from 7,620). Of citations issued for hazardous offenses, 6,642 citations were issued for speeding in 2011, which represents a 27% decrease compared to the 9,039 speeding citations issued in 2010. Overall, the Traffic Enforcement Safety Team issued 6,615 citations in 2011, as compared to 8,192 in 2010. This represents a decrease of 19% in the total number of citations issued as compared to last year. The number of hazardous violation citations issued by the TEST unit decreased 27% in 2011, from 5381 to 3955. The number of citations issued by the TEST unit for non-hazardous violations increased 8%, totaling 1,847, up from 1,702 in 2010.

Several factors may have influenced the drop observed in citation totals from 2010 to 2011. The most significant of these factors was the increased staffing demands placed on the Madison Police Department during the first and second quarter of 2011, when events at the State Capitol, stemming from the introduction of, and protests surrounding, the Budget Repair Bill were transpiring. Numerous MPD officers, including those in the TEST unit, were reassigned duties around the Capital during this time frame. This adversely impacted the availability of officers to perform traffic enforcement, and likely correspondingly affected the number of citations that were issued. The corresponding return of citation levels to more typical and consistent levels in the third and fourth quarter of this year appears to support this. Other factors which can influence citation totals, and may have contributed to the overall decrease in citation totals for 2011, are significant crimes and crime trends. Trends vary from year to year, and in 2011, the City of Madison experienced an increase in homicides, as well as, a surge in "beat down" style robberies. The nature and investigation of events such as these dictate the application of large amounts of resources in their investigation and therefore can impact the availability of officers to perform selfinitiated duties, such as traffic enforcement. Despite these factors, members of the Madison Police Department remain cognizant of the overwhelming support traffic enforcement receives from the citizens of Madison, and of the vital role traffic enforcement plays in the safety of our community. The Madison Police Department remains committed to keeping traffic enforcement a priority in the year to come.

The Traffic Complaint Hotline (previously known as the Speeders Hotline) received 288 citizen calls during the fourth quarter of 2011. 112 warning letters were sent as a result of these reported violations. For the year, 1,100 citizen calls were received, and 517 warning letters sent. For the fourth quarter, Crossing Guard and school bus driver observations resulted in 702 warning letters being mailed and 77 citations issued. For the year, Crossing Guard and school bus driver observations resulted in 1,887 warning letters being mailed and 169 citations issued.

Sixteen traffic enforcement overtime grant initiatives were scheduled for the fourth quarter of 2011. The relatively small number of initiatives was largely due to the close of the 2011 grant cycle in September, and to the delay in waiting for approval for the funding of the 2012 grants. The sixteen grant initiatives conducted were coordinated through the Department of Transportation, Bureau of Transportation Safety, and focused on impaired driver (OMVWI), excessive speed and pedestrian safety. These initiatives resulted in 314 citations being issued.

In the fourth quarter of 2011, Madison Police Department Traffic Specialists investigated seven significant traffic crashes resulting in death to two individuals. Driver use of drugs and/or alcohol is being investigated as a possible factor in three of these crashes. For the year, Traffic Specialists investigated 24 significant traffic crashes. Fourteen fatalities resulted from these crashes. Nine people suffered serious injuries as a result of these crashes. Alcohol or drugs were determined to have been a factor, or are being investigated as a factor, in eleven crashes.
