The City of Madison is proposing to reconstruct the street and underground public utilities along the above referenced streets in 2012. You are being sent this letter to notify you of a public hearing before the Board of Public Works regarding the project, at the above referenced date, time & location. City Engineering will make a short presentation at the meeting, followed by the public hearing. The project will involve special assessments to owners of property adjacent to the project. Attached to this letter is a Schedule of Assessments, which shows estimated costs for each property adjacent to the project.

The proposed project limits are as follows:

- Merrill Crest Drive from Regent St. to Langlois St.
- Langlois Street from Merrill Crest Dr. to Whitney Way

The proposed work on Merrill Crest Dr. and Langlois St. is a complete street reconstruction including installing new curb and gutter and replacing the pavement, sanitary sewer, water main, storm sewer, and drive aprons. Sidewalk is not proposed with this project. The project is scheduled to take place during summer 2012 with a tentative start date of June 11th.

Street Improvements

The proposed street improvements include installing new concrete curb and gutter, which will improve drainage on the street and limit erosion along the existing street. The proposed improvements also include removing and replacing the asphalt pavement, and replacement of the driveway aprons. The existing asphalt and concrete driveway aprons will be replaced with the same material, and existing gravel driveways will have a new concrete driveway apron installed to match into the curb. The replacement of the driveways will be limited to only the amount necessary to match into the new curb.

With the installation of the curb and gutter, the street widths will be changed. Langlois Street and Merrill Crest Drive are both proposed to be 28 ft. wide.

The City and the property owners adjoining the reconstruction will share the cost of the street improvements. Since Merrill Crest Dr. and Langlois St. are currently unimproved streets (no curb and gutter), the entire cost of the curb and gutter and 4 ft. of the pavement will be assessed to the adjacent property owners. The City shares the cost on a 50-50 basis with the property owners for removing and replacing the asphalt or concrete driveway aprons. The entire cost to install a new concrete apron where the existing driveway is gravel is assessed to the property owner. The City assumes the entire cost for the remaining portion of the new pavement and storm sewer improvements. The City also assumes

the cost for curb and gutter and pavement located at each street intersection. The attached Schedule of Assessments shows a breakdown of costs for each street reconstruction items and the total estimated cost to be assessed to each adjacent property owner. Sanitary Sewer Main and Lateral Replacement

The sanitary sewer main and laterals within the limits of this reconstruction project were constructed around 1941 on Merrill Crest and around 1952 on Langlois. The sanitary sewer main will be replaced with the project and will not be assessed to the properties. Sanitary sewer laterals are owned by the property owners and it is their responsibility to maintain them. It is the City of Madison Engineering Division's policy to pay for 75% of the cost to replace sanitary laterals within the public right of way (the length of sewer lateral between the sanitary sewer main and the property line) while the property owner is assessed the remaining 25% of that cost. The estimated property owner's share of the cost for lateral replacement within the public right of way is listed on the Schedule of Assessments. Replacement of the sanitary sewer lateral from the property line to your home is solely your responsibility and will not be coordinated or funded by the City. If you have questions regarding the replacement of your sanitary lateral please contact Max Conway, of my staff, at 261-9127 or at mconway@cityofmadison.com.

Storm Sewer

With the installation of the curb and gutter, storm sewer will also be installed with this project to improve the drainage of the street. There is some existing storm sewer within the project limits on Merrill Crest Dr., which will be replaced as necessary with this project. The costs of the storm sewer construction are not assessed to the property owners. Max Conway is also the storm sewer designer for this project; you may contact him with questions at the above phone number.

Water Main and Water Service Laterals

The existing water main on Langlois St. was installed in 1940, and the existing water main on Merrill Crest was installed in 1963. There has been a significant amount of water main breaks within the limits of this project, so these mains will also be replaced with this project. The City will abandon the old main that currently serves the properties and will connect all of the properties to the new water main. Property owners will not be assessed for the new water main. Please contact Dennis Cawley of the Madison Water Utility at 261-9243 with questions regarding water main or service replacement.

Street Landscaping

Tree pruning in advance of the project is required to reduce the risk of damage to the trees during construction. The City of Madison-Forestry section will perform the necessary work. For certain species, especially oak and elm trees, the pruning must be completed by April 1 to reduce the chance of disease.

During construction, it may be necessary to trim existing tree limbs and/or roots to accommodate the construction. Tree conflicts are often encountered with sanitary sewer lateral replacements, and there is also the possibility of tree conflicts with the installation of the new curb and gutter. If, during the course of construction, it is determined that a tree must be removed, City Engineering will notify property owners adjacent to the tree to be removed, prior to removal.

One tree removal has already been identified. The 10" diameter green ash tree located along the Langlois St. frontage of 110 N. Whitney Way (Mount Olive Church) near the intersection with Merrill Crest Dr. will need to be removed with the project. Please note that most of the trees along Merrill Crest Dr. are at risk because they are relatively close to the existing street, so the street construction could impact these trees, but the City will take precautions to limit the impacts on the trees as much as possible.

When the project is complete, City Forestry Section will evaluate the terrace area for new street trees or replacements. Street trees are typically planted in the spring of the year following the completion of the construction project. Tree species selection is determined by the Forestry Section.

With the nature of this work, property owners should anticipate that most of the terrace will be disturbed, therefore, any plantings or special landscaping features that are near the street that an owner wishes to save from damage should be removed from the terrace area prior to the start of construction.

Special Assessments - General

A special assessment is a special charge for work that the City is planning to complete. The attached Schedule of Assessments shows an *estimate* of the property owners' share of the project costs based upon the City's assessment policy. After the project is bid, and work is complete, a final assessment will be calculated based on bid prices and work actually performed. The final assessment, which will be billed after the completion of the project, is payable in one lump sum or over a period of 8 years, with 3% interest charged on the unpaid balance.
