#### BPW 6/20/2012 Handout

The plan is to open the gates located at the Jerome Street and Bainbridge Street intersections of E. Coldspring Avenue during the remainder of the 2012 Monona Drive reconstruction project and also during the 2013 Monona Drive reconstruction project. Monona Drive has been reduced to a two lane undivided roadway during construction and left turning movements can't be accommodated during construction. Currently the gates are closed during the weekday hours. Opening of the gates will allow for better traffic circulation during the reconstruction process.

The project currently underway is expected to be completed by October 31, 2012. The 2013 project includes Monona Drive from Winnequah Road to Pflaum Road is expected to start March 18, 2013 and run through November 15, 2013.

We are aware of the neighborhood concerns for safety with increased volume of traffic. As part of this proposal staff will work with both the City of Madison and City of Monona Police Departments to patrol and enforce traffic laws. The Monona Grove School District will educate their staff and students about these concerns and stress the importance of safe and courteous vehicle operation.

Dear Christy,

I received your public meeting notice just one week prior to the scheduled meeting, which I wish would have been sent earlier to allow enough time for discussion and ample time for people to work around busy schedules in order to attend.

I am opposed to opening the gates on Coldspring Ave. I believe the city acted prudently when the gates were installed and that opening of gates will be a danger to pedestrians in the neighborhood.

I have concerns for increased traffic, particularly during high-traffic periods near Frank Allis School during drop-off and pick-up times. Additionally, cars are often parked on one side of Jerome near Frank Allis, which narrows the road and I believe increased traffic would be dangerous for pedestrians.

As you know, we do not have sidewalks like Buckeye, Pflaum, Monona, and Cottage Grove roads do, and feel this increase in traffic during high-volume times will cause an undue burden for the many pedestrians and bicyclists that use our peaceful neighborhood streets.

Aside from the pedestrian concerns, I am concerned about noise, speeding Monona Grove commuters and potential damage to the chip-sealed roads, which I presume were not engineered for the same volume of traffic as Monona Drive, Pflaum and Buckeye.

If you must open gates, I strongly urge you to reconsider the gate opening at Jerome, to avoid potential dangers to elementary school children that walk across Jerome to get to school. Additionally, I believe radar enforcement on any roads would be a good idea.

Thank you for the opportunity to provide written comments regarding this issue. I sincerely hope the City will listen to residents' concerns and not open the gates.

I am contacting you in regard to the current plan to open the gate on E. Coldspring Ave. during the upcoming school year, as was suggested in the City Engineering Division letter mailed to us, dated 6/7/12. I wish to let you know of my continued concerns, and in doing so hope that advance positive planning may result.

My husband, Steve & I have lived at 4211 Jerome Street for nearly 16 years. In those years, we have experienced much abuse previous to having the gate installed, on the part of the MG students speeding recklessly and behaving disrespectfully toward our properties. There are many young families on our street with small children in danger. Jerome Street also has many life-long residents who are elderly. They also feel threatened.

In past history, notifying either the Madison police or the Monona police had been problematic because this street appears to be at a "boundary" that was, perhaps, confusing(?) for them or not worth their energy(?). I have been treated disrespectfully by the police, when reporting incidents/specific vehicles that chronically speed, throw objects, or behave dangerously and as though Jerome Street is a "free for all". This is unacceptable. I dread this recurrence to start up again, as we all have the right to feel safe. While I can truly accept that the gate should be kept open during off-school times, such as during the summer months, I am feeling quite tentative toward having this gate open through the upcoming school year. I need to understand specifically how the two police departments will work together to insure that Jerome Street will remain safe for all its residents.

What we did not have a chance to talk about Monday night - Monona Drive Reconstruction Dear Mayor Soglin, The purpose of this letter is to request your consideration for residents of Jerome Street and Lakeview St. as the city considers opening the traffic diverters on Jerome and Coldspring St. As a result of conversations with Christine Bachman of City Engineering, I have learned that the purpose of opening the diverters is to provide some relief for construction workers and provide additional options to residents and the students and teachers at Monona Grove High School. Ms. Bachman appears to understand that opening the diverters would not provide an additional viable option for Monona Drive traffic. The few people from the neighborhood that would use Coldspring if the diverters were open simply will not make a meaningful difference on the traffic count on Monona Drive. Residents on Jerome, Lakeview, Bainbridge and Winnequah are legitimately concerned about the high speed traffic from the school. The traffic diverters were not our preferred option but they have eliminated about 90% of the problems. These streets are not built for high speed traffic. They have a significant number children, walkers, and bikers. Lake View is on the Lake Monona Bike Trail. At the north end of Jerome around a blind corner is Frank Allis elementary school. MGHS students use Jerome and Bainbridge Streets for band practice and athletic warmups. Residents fear for their children and others before, during, open campus and after school hours, and before, during, after athletic events, and practices and special events. Now Monona Grove High School is adding insult to injury. As you may know Monona Grove School District has owned two vacant residential properties in the City of Madison on the south end of Jerome Street for more than 20 years. The school district pays no taxes on these properties. Over the years MG school district has deprived Madison taxpayers of an estimated 150,000. In addition the houses are not maintained, in disrepair and a blight on the neighborhood. Monona Grove High School is now cutting brush on the school grounds and transporting it to 4217 Jerome St, the property they own but do not pay taxes on in the City of Madison, so the City of Madison will pick up and remove this debris. I expect that a number of neighborhood residents will be understandably outraged when they learn this. They will likely be even more opposed to opening the traffic diverters to accommodate Monona Grove High School. As you may be aware, the opening of the traffic diverters is scheduled for discussion before the Board of Public Works on June 20th. I hope that we can come to a better resolution.
