Hi my name is Steve Gallo. I reside at 916 Jenifer Street. I live in one of the households affected by the amplified bass music coming from Plan B, Thursday thru Saturday nights from 10pm until 2:30 pm.

I've come before the ALRC committee to seek a solution to this issue. I do not believe it is a far reach to place conditions upon Plan B to soundproof their building so that the affected neighbors can sleep in their own homes.

There has been a precedent in Madison to having entertainment establishments fix their building structures to eliminate or greatly mitigate bass music escaping their buildings. I can point to the Highnoon Saloon, located at 701 East Washington Avenue, Jolly Bobs at 1210 Wiliamson Street and the Goodman Community Center at 149 Waubesa Street. All these venues have made adjustments to their buildings so that the affected neighbors were able to experience more peace and quiet.

This is not a complicated issue to understand. We have all been at a stop light with our windows rolled up and we can hear the bass thumping from some car in our vicinity. Bass waves carry a lot of energy and can transmit through solid enclosures. Another example we have all experienced is we can hear the thumping bass coming from a car blocks away. Bass waves, due to their nature, can travel and be heard

over long distances.

I would also like to address to the committee that we are not here to seek the revocation of Plan B's liquor license. I'm stating directly to you, that my intent here is only to fix the nuisance noise issue. I feel that I am compelled to express to the committee that the owners of Plan B have misrepresented my position, in their haste to garner support.

Furthermore, I would like to state that I have supported Plan B's desire for an increase in capacity from 250 to 300 people. I did this with the hope, that the increase in revenue stream would help support any building alterations that were needed to resolve this noise issue. I have estimated that this is no small amount. The increase in revenue over the last two years, amounts to \$50 - 75,000 dollars and they are adding to their bottom line everyday they are in business going forward. There should be no reason they can't afford to soundproof their building.

Finally, I would like to thank the ALRC committee for their attention to this matter and their service to the community. Two in a half years ago, when I heard that a dance club was coming into the neighborhood, I was excited and a little nervous. Excited that there would be a cool club for people to go dancing and have some fun and nervous that it might be quite noisy in regards to drunken behavior. I remembered those fun times, having spent many years, back in the 80's, going to the New Bar, which was a fun danceclub in the old Hotel Washington that later burned down. I assumed that Plan B would be a hip addition to the neighborhood, so I supported it, not knowing all of the issues that would come along with having a nightclub next to a residential neighborhood.

Fast forward 2 years and 9 months later. My husband and I live directly across from Plan B, up the hill on Jenifer Street. We can see Plan B's entrance from our back bedroom window. We bought our home in 1993, when Plan B was still Star Photo. When we bought our home many years ago, people would ask, "Why do you want to live in that neighborhood, it's so run down and their is a lot of crime?". We would say, it's going to be a great place to live, it's close to downtown and the old run down homes will be eventually fixed up. So we bought an old neglected victorian and for the past 19 years, we have been investing lots of time, energy and finances into making it our castle. In 2006, we enlarged our bedroom, which was the size of a large closet, with an addition. It's a beautiful space, but unfortunately, we can no longer sleep in it on Thursday, Friday and Saturday nights because of bass noise, coming from Plan B that goes up the hill and penetrates our bedroom, with thumping noises that cannot

be blocked out by fans, white noise machines or closed windows. So now we go out to our living room, which is located in the front of the house on the Jenifer side, to sleep on our couch every Thursday, Friday and Saturday nights. We wake up feeling stiff, sore and exhausted many of those mornings after a night on the couch. Our home is no longer our castle.

In the beginning, around one month after Plan B opened, we were invited to a neighbors meeting with them, which was facilitated by Scott Thorton, the neighborhood president of the Marguette Neighborhood Association. At that time, we had told them about the bass noise that was waking us and keeping us awake at night. We told them is was very bothersome and we could sometimes feel the vibrations in our stomachs. They seemed very accomidating in the beginning and assured us that the problem would get fixed. They did a few things that they felt would alleviate the bass from us hearing it, such as intalling bass traps and getting a limiter. Neither of those things eliminated the bass waves and about a year ago we learned, from Mark Wolff and a sound engineers report that the bass was coming up through their roof. Since our home is at the top of the hill, directly facing Plan B's roof, the waves then directly travel to our back bedroom with no buildings to block them or lesson their impact. They were told that this could be fixed by applying mass loaded vinyl to their roof, which to this day, still has not been done.

When Plan B learned that the bass was exscaping through the roof, they offered us a solution, that they

would apply the mass loaded vinyl only if we would OK a second floor outdoor patio addition and later on an increase in capacity. We have told them that we feel that this is an unacceptable solution to a probem that has been going on long enough. Beyond the bass problems, we have many other issues with noise, but we have accepted that and keep our windows closed and our white noise machines on. They are now telling their customers that we are making this up, that we are trying to close them down and that we are being unreasonable. All three statements are very far from the truth. They have made our lives very uncomfortable. My job, as a teacher, is very hard on Fridays and my health has been affected by not getting a good night's sleep.

All we want is to be able to slumber in our bedroom without hearing bass thumping every Thursday, Friday and Saturday nights. Is that too much to ask? I think it's very reasonable.

Status Update regarding Plan B

This memo summarizes actions taken by Plan B to mitigate sound concerns raised by certain of Plan B's neighbors, and confirms that Plan B has had ongoing dialogue with the Marquette Neighborhood Association, the District 6 Alder and others with respect to its operations.

#### MY BACKGROUND

Plan B opened for business in 2009. I assisted Plan B in organizing their limited liability company and negotiating the lease with the owner of 924 Williamson Street. I have also been a resident of District 6 for over 30 years. For the past 25 years, I have practiced law in Madison. More than half of my law practice has involved representing municipalities, whether as the municipal attorney or as special counsel. Given the time and effort it has taken to review the relevant history and law, I thought it would be useful to provide a summary that would be available for future reference.

#### SUMMARY OF ACTIONS TAKEN TO DATE

Over the course of the last two years, a variety of actions have been taken to limit noise that naturally arises from a commercial enterprise such as Plan B and to address noise concerns expressed by certain neighbors. The following list summarizes the actions taken by Plan B:

- 1. Mr. Rolfsmeyer owns the only residential building that is directly adjacent to Plan B. The Rolfsmeyer property is actually east of Plan B's parking lot, and there is almost no side yard between the parking lot and the building. Both Mr. Rolfsmeyer and his tenant expressed concern about noise, and the tenant noted that the bedroom window faced the parking lot. In addition to other actions described below, Mr. Sabatini and Mr. Gresen responded by paying for and installing a six-foot high privacy fence between the Plan B parking lot and the Rolfsmeyer property.
- 2. In part to mitigate concerns regarding the noise from patrons during and after the hours of operation, Plan B directed patrons to two nearby parking lots that are in exclusively commercial areas, thereby directing patrons away from mixed and/or residential areas. Plan B leases these additional parking lots on a monthly basis, thereby adding thousands of dollars of costs to Plan B's operations.
- 3. Plan B actively monitors noise and safety in all of Plan B's parking lots. Plan B has additional security personnel that regularly patrol the parking lots and outdoor areas near Plan B. Security personnel are specifically directed to address any heightened noise that may occur in the parking lots. While this level of coverage comes at an added cost, it is part of how Mr. Sabatini and Mr. Gresen want to treat their neighbors.
- 4. When concerns were raised about noise escaping the premises as the backdoor of the club opened and closed, Plan B responded. Plan B changed the swing of the backdoor of the club and built twelve-foot high walls around the back door so that sound would project toward the commercial area behind Plan B (that is, toward Paterson Street and East Washington Avenue) rather than toward the mixed use and residential area across the street from Plan B (that is, across Williamson Street and toward the Marquette Neighborhood).

- 5. Similarly, Plan B thought about possible noise concerns arising from the front door entrance, which is on the Williamson Street side of the building.<sup>2</sup> An additional security post was added so that, if there is a line outside of the front door, the door is closed as patrons enter and security personnel is available to address any concerns that may arise regarding patron store outside of Plan B.
- 6. Mr. Sabatini and Mr. Gresen require their DJs to announce to patrons at closing that they should keep their voices down as they leave because Plan B so that noise doesn't drift from the commercial area to residential portions of the neighborhood.
- 7. Plan B does its best to hold down the noise associated with disposal of bottles and similar trash in the outdoor dumpsters. Plan B has policy of NOT placing any empty bottles or other such containers in the dumpster after 10:00 pm. Plan B does not throw bottles in the dumpster at bar time. Bottles that are emptied after 10:00 pm are held for disposal on the next day. Again, this policy was adopted out of consideration for their neighbors.
- 8. Mr. Sabatini and Mr. Gresen have met several times with a group of neighbors who are concerned about noise coming from Plan B on Thursday, Friday and/or Saturday, late at night through bar time. Plan B has taken several reasonable actions to address this group's concerns, including the following:
  - a. Mr. Sabatini and Mr. Gresen hired a sound professional experienced with music venues. This professional confirmed that it was the bass sound that "traveled" out of the building.
  - b. In order to keep more of the bass in the building, Plan B installed bass traps throughout the club. These bass traps are specifically designed to trap bass sounds inside, and thereby reduce the impact of bass outside of the building.
  - c. Plan B then paid for a formal study by a sound professional. (This analysis was distributed previously.) The study found that, although the sound levels escaping from the building were not at a point where the professional would expect neighborhood complaints, additional action could be taken to mitigate the escape of sound from the building. Two options were set forth: (1) the use of a "limiter;" and, (2) installation of "mass loaded vinyl" under the roof.
- 9. Although not required to do so, Mr. Sabatini and Mr. Gresen purchased and began using a limiter to reduce low bass frequencies. Mr. Sabatini and Mr. Gresen spent

more than \$2,000 on the limiter in order to address the alleged noise problem advanced by this group of neighbors.

#### **ACTION TAKEN BY THE CITY**

The City has also taken direct action to investigate and monitor noise coming from Plan B. Please see the May 11, 2011 Memorandum from Assistant City Attorney Jennifer Zilavy regarding "Plan B Noise Issues." This Memorandum details actions taken by Ms. Zilavy and Mr. Bill Nietzel of the City Building Inspection Unit over the course of several unannounced on-site inspections. Decibel levels of the noise were measured and reported. While the Memorandum speaks for itself, allow me to include the following sentence from page 3 of the 4 page Memorandum:

In summary, the decibel readings as well as the personal perceptions of Mr. Neitzel and myself (Jennifer Zilavy), lead to a conclusion that the sound level of the music and bass coming from Plan B is not unreasonable and is certainly not excessive. From what I observed, the owners have a very well-trained staff and are very conscientious of keeping their patrons in order.


#### POSSIBLE FUTURE ACTION

Plan B has acted in good faith to consider its neighbors and will continue to do so by maintaining regular contact with MNA. Certain neighbors insist that Plan B install mass loaded vinyl on the roof now. Mr. Sabatini and Mr. Gresen would be willing to do so as part of a remodeling project on the second floor of the building, provided that ALRC approves a change in the description of the premises. (Note: Plan B would not be requesting an increase in capacity concurrent with the remodel.)

Plan B is in the process of obtaining input from stakeholders regarding the remodel. It would be a significant additional investment in the building, but might be a winning possibility for all involved. We will continue to keep the City aware of our progress.

Hello, my name is Lynn Lee. I am here with my partner Steve Skaggs and our daughter Addison.

We live at 922 Jenifer.

We bought our home in July of 2009 before the club opened. It had been on the market for 10 months, with many accepted offers falling through after the inspection. It was a neglected run down duplex in need of a complete overhaul.

We spent 5 months renovating it, doing all the work ourselves to turn it into a single family home.

In April of 2011 we were the first two dad family to have our home and our family featured in Madison Magazine. The attic playroom I created for our daughter was featured in Brava magazine last year.

We have our life savings, countless hours of hard work, and family memories in the home we created for our daughter. We cannot afford to move, nor do we want to. We love our home.

But, we can not sleep in our home 3 nights a week. Thursday through Saturday we hear the music and feel the bass thumping in our chests as we try to sleep. It goes from 10-2 in the morning. Thursday is the worst, because we get up at 5:30 a.m. With just three and half hours of sleep.

Our jobs are being affected as well as our health.

Our daughter who never had a problem sleeping since birth, suddenly began waking up repeatedly on these nights. We have tried running fans, sound machines, and music, but nothing removes the bass beat thumping in our chests.

My partner Steve has taken to sleeping on the couch three nights a week, while I sleep with Addison in a guest bedroom in the front of the house on really bad nights.

We should not have to live this way.

In 2010 we began meeting with the bar owners to solve the issue. Many times the bar owners stated "if we knew how to fix the problem we would." We believed them. The owners even stated that they looked forward to winter so there would be three feet of snow on the roof to trap the sound and bass. This year we had very little snow.

After a year of us asking, they had a sound engineer come in who after inspecting Plan B reported the problem could be fixed if the wooden roof was soundproofed.

I have turned into you this audio specialist report and the initial estimate the

owners of Plan B supplied to have the work done.

The neighbors have offered to hold fundraisers to help raise the funds to sound proof the roof. The owners of Plan B never responded to our offer.

We now know how to fix the problem; we offered to help raise the money to fix it; but they had other plans.

Instead, they asked the neighbors to support a second story expansion (directly in line with our bedrooms) of a lounge and outdoor smoking patio with an increase of capacity of 50 people. If we agreed, they informed us they would soundproof the roof.

We could not agree to those terms. From October of 2010 to now they have told us if we want to sleep in our homes, the only solution is for us to support the expansion on to the roof. After two and a half years of working with them it felt like arm twisting to get the second floor expansion for the ability to sleep in our bedrooms.

I have turned into you the letter from their attorney stating this proposal on the behalf of Plan B.

The idea of 50 people, drinking on an outdoor smoking patio directly in line with our bedroom windows is not something we could support after the way they have dealt with this current issue.

At our last meeting, the owners ,Rico Sabatini and Cory Gleason stated they might do nothing. Mark Wolfe, the city assistant attorney, and Alder Rummel stated this could result in the separation of their liquor license so that conditions could be placed to resolve the issue.

They decided to do nothing and here we are today.

We are the four families that live directly behind the club's un-soundproofed roof. Is it any wonder we are the four having the issue?

I can assure you Steve and I never wanted to be in this position. That is why we worked with Plan B for over two years to resolve it.

At no point in any of the many meetings did we discuss working to revoke the liquor license of plan B. In fact we supported, when asked by the owners, a capacity increase of 50 people two years ago. We were told that the increase in revenue from cover charges and liquor sales would help pay for the cost to fix the problem.

They did not follow through and we are now asking you to place those conditions on Plan B's license so we can sleep in our bedrooms at night.

Finally there is a petition that Plan B sponsored that will be presented today in support of their club. It states we are trying to shut the club down. As members of the gay community, as I read the petition, Steve and I would have signed it. Except, it is purposely misleading and does not present the facts of this issue.

This petition should be considered as a statement of how popular the club is, but not relevant in resolving this issue.

For a club to purposely mislead their patrons, attack individual neighbors and try to steamroll an ALRC meeting is irresponsible.

A business should not purposely divide and mislead the community it operates in. Furthermore, for the owners of Plan B to perpetuate and encourage the falsehood that Alder Rummel and the neighbors are homophobic, after we spent over two years to help them resolve this issue they created, is truly disturbing.

This irresponsible behavior should not be rewarded.
