

Upon Assigned Creditor's motion for an order appointing a receiver of the property of Eric Fleming, defendant herein,

Defendant having appeared at a supplemental examination before Scott Herrick, Court Commissioner for Dane County, Wisconsin on October 28, 2011, November 15, 2011, November 22, 2011, December 5, 2011 and December 9, 2011, and said defendant having been examined and having answered concerning his property, and it appearing from the examination and the answers of the defendant that said defendant has property which is not exempt under Wisconsin law, and it appearing that no other receivership arising out of a supplemental proceeding is pending against said defendant.

Receiver Douglas Mann, has been appointed for Eric Fleming's right and title interest in and to 216 State Street, LLC, State Street Properties II, LLC, and State Street Properties I, LLC and associated real estate, in Waukesha County Case No. 09 CV 4898.

Pending defendant's compliance with the foregoing, the defendant is hereby enjoined and restrained from making any transfer or other disposition of any property belonging to the defendant not exempt from execution by law, and from interfering in any way with the receiver or the rights of the said receiver in connection with said property.
