UW Digestive Health Signage Overview

The signage proposal is for the UW Digestive Health building in the University Crossing development located on the corner of University Ave and Whitney Way

The surrounding uses are as follows: To the north are residential neighborhoods; to the east are commercial sites; to the south are commercial sites; and to the west are commercial sites.

We are proposing a total of three internally illuminated wall signs, one address sign and a total of two internally illuminated ground signs.
