

1.1 Company Summary

BJ&MSF a small artisan butcher shop that sells artisan sausage, cured meats, steaks, roasts as well as sandwiches, prepared foods, cheese, wine, beer & kitchen wares. The business is operated by members of the Underground Food Collective. The explicit goal of the shop is a comfortable, neighborhood-driven space that provides sustainable and quality products to our clientele. It is our goal to design a small, signature space that encourages collaboration and interaction among the staff to create innovative use of local and seasonal ingredients.

1.2 Company Ownership

BJ & Mel's Sausage Factory, LLC is a Wisconsin, Limited Liability Company that is managed by three members of Underground Food Collective mentioned below.

1.3 Service Summary

The butcher shop will focus on four main areas of service ::

Sausages and Whole Cuts: BJ&MSF will carry between 4 and 10 sausages daily - made inhouse. Varieties are to include pork, beef, goat, rabbit, lamb and occasionally game meat. The varieties will vary seasonally and be heavily rooted in tradition while allowing for creative interpretation of those traditions. On any given day you might see merguez, hot dogs, boudin blanc, weisswurst, bratwurst, morteau sausages in our case. We also plan to offer full cuts of meat - beef, pork, lamb and goat. There is a strong demand for high quality meats in Madison - and we are excited to offer locally sourced cuts. We plan to have birds in our case as well - with a focus on heritage varieties that include silkies, poussin, reds, ducks and pheasants.

Cured Meats and Cheese: BJ&MSF will have a full service charcuterie counter that will include the entire line produced by Underground Meats. Charcuterie will be cut to order as well as taken home whole. We also plan to carry rillettes, patés and terrines - all made in house. On top of this we plan to carry a selections of artisan cheeses from across the United States.

Sandwiches and prepared foods:

BJ&MSF includes a sandwich counter, serving to-go sandwiches & take-away catering for small events. The prepared foods will consist of salads, sides and small eats that can be purchased along with the customers meats or charcuterie needs.

Grocery: Grocery items will include high quality produce, preserves, dry goods, oils & small production bottled beer & wine. We will sell new & up-cycled kitchen wares - such as aprons, cutlery & cutting boards.
