Erdman provided the update for the Village on Park:

- Currently waiting for a proposal for construction of the landlord work.
 Waiting for Lanes Bakery plans and estimates.
- Access putting up barricades today, construction fence on Wednesday. Will be very tight on parking. Sending out notices to tenants.
- Working on agreement with Centro Hispano for 10-15 spaces across Hughes.
- CDA, along with Urban League, Sustain Dane, Planet Bike and WIBIC are planning Eat, Play & Bike from 6-8 p.m. on each Thursday in June. Food vendors, Farmers Market, musical events, various non-profit organizations for placemaking. Loaner bicycles available. Two guys will do bike repair for people. Bike safety for children and adults. Bike parade last night through neighborhood. Turn parking lot into a community center at night. Working with Ald. Skidmore for landscaping.
- · Make Music Madison on that Friday.
- Switch Board meeting to June @ The Village on Park.
- · Asbestos removal will be done at end of year.
- Roof can't be redone until asbestos is removed.
- Ask for remaining money from Access sale (\$200,000). That should allow us to do asbestos remediation.
- Roof will do half of Atrium.
- Thompson-Frater asked if we sell something, are we free to use that.
 Erdman said if the Council approves it.
- Have 1200 feet in the lower level to set up a classroom.
- 1200 feet next to Lanes.
- 1000 feet on second floor next to Atrium.
- Can't sell North parcel without addressing the parking issue.
