Dear Alders and City of Madison Representatives:

I attended the public hearing Thursday night (5/2/13) regarding Wingra Boats proposed business at Brittingham Beach. Upon arriving to the beach house I saw many watercraft and furniture items had already been moved on premise. A platform deck was already inprocess of being built. And at this meeting, I learned that Wingra Boats is proposing to start their business with 67 watercraft rentals in the bay (a combination of kayaks, paddleboats, motorized pontoon boats (3), stand-up paddle boards, and I believe they said rowboats too). In their words, they 'hope to be able to expand' from there.

According to Dane County Community Planning and Analysis Division (2004), Monona Bay is a 187-acre water body (on the western edge of the neighboring 3,300-acre Lake Monona). The 'triangles' are included into the estimated size of Monona Bay. The north triangle is 14 acres and has two openings to the lake and one to the bay. The south triangle is 13 acres and has two openings to the rest of the bay and one to the lake. Thus making the size of the main body of water herein called 'Monona Bay' approximately 160-acres. Monona Bay has mixed use of watercraft currently (by residents of the bay and traffic coming into the bay from Lake Monona). Currently Monona Bay also has a 200' slow no-wake zone to the shoreline (further reducing the navigable water area available for motorized watercraft).

As residents at 833 South Shore Drive my husband and I are home owners with riparian rights on Monona Bay. We have a number of concerns regarding this proposed business and we are opposed to this proposed business plan (as-is).

CONCERNS:

- 1) We feel there was a lack of due process to involve ALL residents of Monona Bay on the use of the boathouse. As a resident on South Shore Drive, we were not contacted (confirmed by multiple neighbors on both South Shore and West Shore Drives).
- 2) We feel there has not been any consideration to the approach of conditional use for the water for mixed use to ensure that ALL rights are Respected.

Wingra Boats currently has a place of business at Lake Wingra (a slow no-wake body of water). When asked if they ever are at full capacity at Lake Wingra, the answer was 'yes, especially on holidays'. Comparisons of this business on Lake Wingra have been made to that of how the business 'will be run' in Monona Bay (which again is NOT a slow no-wake body of water). Especially on holiday weekends, Monona Bay has its own residents using their own watercraft such as canoes, kayaks, stand up paddle boards as well as motorized boats pulling skiers, families pulling their children on floatables behind their boat, and many boats with people fishing. Additional watercraft traffic comes into Monona Bay from Lake Monona. While we believe a business would have positive implications on the area, there has been NO consideration given to the number of rentals and how this will affect those homeowners with riparian rights on the bay. This business may effectively shut down a property owner's ability to navigate in the bay for mixed use.

As it is the NUMBER of rental watercraft in which Wingra Boats is proposing that of most concern (based on the size of Monona Bay), we suggest the following.

PROPOSED SOLUTIONS:

- 1) Limit the number of watercraft rentals of this business to be appropriate for the size of Monona Bay or consider an alternate site for this business that would allow for this volume of watercraft rentals (ex: Olin site on 3,300 acre Lake Monona or utilize another slow no-wake (motorized watercraft restricted) body of water such as Mud Lake).
- 2) (Currently motorized watercraft making a wake within the bay are restricted to the area outside of the 200' to shore) Require the conditional use of non-motorized watercraft limited to within 200 feet from shore. Additionally, for group programs such as the proposed teaching clinics for non-motorized watercraft, it is suggested that the business utilize the already no-wake area of the North triangle (14 acre waterway between Monona Bay and Lake Monona).

We have lived on the bay for 6 years and we purchased our home on the bay with the intent of raising a family, towing them behind our boat, teaching them how to waterski... just as we ourselves learned when we were 4 and 5 years old. We also embrace silent sports and own non-motorized watercraft. We are disheartened to learn about this proposed business seemingly after it is a 'done-deal' which affects our home. We ask that you reconsider the aspect of the rental watercraft in this business proposal. There should be considerations made that will insure all rights are respected for mixed use of the water (as it exists today) or a more suitable site location should be chosen that can handle these kind of numbers.

Subject: Waterskiers and current safety conditions in Monona Bay

Hi Sue,

Thanks for organizing last night's meeting. I think it went pretty well.

I wanted to share with you a bit more about my concern that the existing status quo with respect to safety and the law in Monona Bay has not been positive. Some of the ski boat owners on Monona Bay have been flagrantly violating the law and disrupting peaceful use of the park and Monona Bay by many neighbors and residents fishing, swimming and kayaking. I have extensive documentation of this problem going back many years. A small number of these skiers (who also happen to be the most frequent water skiers in

Monona Bay) frequently buzz the shoreline and disturb people fishing and swimming. I have also reported these same skiers ignoring other users of the Bay in non-motorized watercraft including my children in their kayaks.

The two attached photos may be of particular interest to you because they show one of the skiers who expressed concern last night about safety in Monona Bay. The first photo is of the neighbor and his ski boat. The second photo is of his boat towing a skier who is about to ski AROUND the "Slow No Wake" bouy (the boat is turning and the skier swung around toward the shoreline a second after I snapped the photo). It is obviously violating both the bouy and the 200-foot rule. A number of neighbors submitted complaints with me about this incident to Deputy Mica Weber at the Dane County Sheriff's office, beginning in 2007.

I live at s. brittingham pl. just [number] houses away from the beach. I support without reservation, the Brittingham Boat proposal. When I moved in the neighborhood nearly 30 years ago, our park was vibrant with activity. It has been heart breaking to watch the deterioration of the park over the years.

We are finally seeing a turn around at the shelter house, with the city rec sports scheduling teams at that end of the park. it is great to see that end of the park teeming with activity. The beach house has been much slower to revive. Things got so low that we witnessed a dead man be removed from the change room after a drug overdose. The city long ago pulled life guard service from the beach.

I have hoped that if the city were unable to reopen the beach, that they would lease the space to a private vendor. This proposal seems like a dream come true. It offers great promise to re enliven the beach area and the bay itself. Right now the bay is used by very few boaters. Most of those are private land owners who live on the bay. Because boat traffic is so meager, there is little law enforcement on the water, and we watch boats constantly coming too close to the shore, driving too fast causing shore erosion. Subject: Why I support the Brittingham Boats proposal

Greetings Eric, Kevin and Commissioners of Madison's Parks:

I wasn't expecting to weigh in again with you all again so soon after the most recent disagreement about different visions for Brittingham Park, but these things happen. As our neighborhood moves forward we face yet another decision that will be welcomed by some and found offensive by others. As I mentioned during the previous difficult decision before you, I love our parks. Whatever differences I may have with any of you or my neighbors, I care deeply about Brittingham Park and I have put my blood, sweat and tears into this common space. I know that you all want the best for the parks as well. I want to share with you my reasons for supporting the Brittingham Boats proposal and some relevant history about this public space across the street from my house.

The beach house at 701 W. Brittingham Place has been an attractive nuisance since I moved in across the street with my young family. I have worked hard with my neighbors to clean the building, plant flowers around it, improve the appearance of the boat racks and pick up trash. Lots of trash. Beginning with the tragic death of an alcoholic homeless man (who was also a registered sex offender) in the beach house a decade ago we have searched for a long-term solution to that building. We have worked with many different people at Parks to specifically find a positive use for the beach house. We worked with former Superintendent Jim Morgan, former beach manager Fritz Kronke, former architect Sy Widstrand, former West Parks supervisor Bill Schott and many others over the years to find a concession and deal with the disuse and abuse of that building. We had a couple of interested businesses but we were unable to get a business to commit. Now we have new faces in the Parks Department who have learned of our long efforts to revitalize Brittingham Park and we have finally found an enthusiastic and experienced local business who wants to start Brittingham Boats. I could not be more pleased!

It would be too easy to simply view the proposal for Brittingham Boats as another concession providing a useful service to residents. That would be positive, but that is not why I am truly enthusiastic to encourage you to approve this proposal. The Brittingham Boats proposal will transform a run-down beach house and difficult-to-monitor part of the Park into a place safe and inviting for all. I have tried to watch over the park myself and tried many different ways to encourage the positive use of the beach area. Unfortunately, we face many challenges due to our proximity to downtown and the trials of a growing city. The beach house has been used for anonymous sex, problem drinking, drug abuse and even defectation over the years and I have found myself removing the detritus of this abuse with my shovel far too many times. It is an embarrassment when young families want to picnic at a beautiful location and there is no running water or clean bathrooms. I have confronted people abusing Brittingham Park and been assaulted. I have cleaned the bathrooms myself and tried to make them available to families on major summer weekends, with only mixed success because it is difficult to monitor the doors to the beach house bathrooms when they face away from the public areas. We have had beautiful weekends when I was able to open the bathrooms and enjoy the sight of big family reunions and diverse groups enjoying the park. These times give me hope, but it is very hard to maintain the building as a volunteer and also take care of my own business and house.

Two years ago the beach was the site of an experimental water filtration system. Neighbors worked hard to keep the area looking nice and I was walking to the area to water the fresh grass seed when I saw a man who had driven onto the freshly-planted area by the beach. He was assembling a Zodiac-style inflatable boat that had a 25 horsepower motor and he was planning to launch it from the beach. He was oblivious to rules, regulation and common decency, and his boat threatened the expensive rubber curtain system and public investment. When I approached him, he became hostile and threatened me. I called the police and the man was ticketed. Unfortunately, he began to stalk me at my house and threaten me and my family. Two tires of our car were slashed and I was forced to get a restraining order against him. This was one of the worst experiences of owning a house adjacent to Brittingham Park and it shook me deeply. It was also a result of this part of the Park having too few positive uses, too many hiding places and the appearance of a rundown public facility that is ignored by the neighbors.

I wanted to share with you this history of the beach house because the Brittingham Boat proposal is the perfect antidote to what has ailed this part of Brittingham Park. Having people, clean bathrooms and eyes on this part of the park will transform this area from a challenge to an asset. We have a precedence for the transformation I see in the Brittingham Boats proposal. Steve Schaefer and his colleagues at Camp Randall Rowing Club has done a similar transformation to the boat house off of North Shore Drive. When I first moved into the neighborhood that building was also run down and an attractive nuisance. Now it is an asset to the Park and to the neighborhood. My daughter rows there, but the benefits to the community extend beyond the direct users of the rowing facilities. People fish from the docks when the rowers aren't using them and everyone benefits from the positive activity and safety provided by the presence of Steve, Russ and all the volunteers at Camp Randall Rowing Club. I see the same energy and possibility from Tyler and Stephan with the Brittingham Boats proposal. I see many of the new residents of the new apartment buildings eager to enjoy the waters that can be viewed from the panoramic windows of their multimillion dollar buildings. I see the long-term residents of the older apartments and modest homes in the neighborhood who enjoy fishing able to navigate a cleaner shoreline and one that isn't strewn with the abuse of the previous night. I see children from local schools learning about our precious water resources through educational programs led from Brittingham Boats. And most of all I see a place where ANYONE can use the most basic facilities we all need many times a day: clean bathrooms.

I am disappointed that a small minority of waterskiers are opposed to the Brittingham Boats proposal. I believe my alder shared with you the problems some of the waterskiers have brought to different users of Brittingham Park, and the photographic evidence of skiers abusing the law. The Brittingham Boats proposal *could* be seen as a business interest versus the interest of residents. But that would ignore the targeted customers of this business: residents and neighbors. It would also miss the tremendous benefits that a revitalized beach house will provide to all users of the Park, and the deterrent to all who would abuse the Park. Waterskiers will continue to be

able to use Monona Bay, but it is true that with more residents fishing, boating and swimming in this revitalized area there may be less open water for skiing. Water skiers may have to motor out to the main part of Lake Monona more frequently or use the existing water ski slalom course by John Nolen Drive instead of the water in front of Brittingham Park. But public parks are meant for multiple users, and the Madison Parks mission is to provide parks "which will enhance the quality of life for everyone." The Brittingham Boats proposal is consistent with that mission and will make an important contribution to the quality of life for residents and neighbors of Brittingham Park.

Thank you for your consideration, and thank you for your service to the common spaces we all love.

I have a great admiration for the way Steve Schaefer and the Camp Randall Rowing Club worked with the City of Madison to restore the historic boathouse on Monona Bay and energize it with a rowing club that has been an important formative influence on many young Madisonians. After a tour of that facility last fall, Steve and I walked across the railroad tracks to the Beach House in Brittingham Park, which has fallen into disuse. Steve was hoping that it could be revived to complement the historic boathouse that his group had helped save. It happened that as we were there we met Stephan Reinke, who was inspecting the Beach House with the hope of starting a seasonal boat rental operation there, just as he and Tyler have done on Lake Wingra. Steve and I came away from meeting Stephan very excited by the prospect. Tyler and Stephan are interested in this as a way to help build and enrich our community and give it access to another Madison lake.

My selfish interest is that Urban Land Interests adaptively reused the historic tobacco warehouses across the street as 61 apartments. Lance McGrath, Joe Krupp, Bob Keller and others have also been creating nice condominium and rental dwelling units in the immediate neighborhood. What Tyler and Stephan propose will give this growing community a place to rent canoes, kayaks, paddle boats, rowboats and paddle boards. Their community contribution will be more that just boat rental. Their café in the Beach House will serve coffee, grilled cheese sandwiches and Babcock ice cream. They are thinking of offering yoga classes and art classes as well. First off, I want to express my deep concern that something affecting homeowners appears to be moving forward like a runaway freight train.

It sounds as though there has been discussion of increasing use of Brittingham Park. While I am ok with that idea (although to be honest I think the park is naturally turning around and with increased density being built around that area - ex new apartment buildings, we are seeing an organic renewal of the park and more use).

I am against the idea of a company using public land to further their business interests. It sounds as though the "angle" of the business is "outdoorzie and natural", but I am concerned that this hasn't really been thought through.

So respectfully I object to this proposal.

(I live on Monona Bay and am an avid kayker. The proposal of renting out what appears to be 65+ and perhaps more boats is simply going to take away from the natural habitat of most of the various species that enjoy that area). There are cranes, loons, North American coots and many other bird species alone that use that body of water for rest stops or their summer habitat. Putting such a large influx of boats into that area will only serve to chase away that population (let's be honest, anyone renting a boat is going to chase after nature). It appears there is a "spillage" effect happening here. Do we want an increased use of the park or a clogging of

the waterways. (Again, can we as residents thoughfully consider all the options). Obviously the for profit company wants to push this through so they can start making money by Memorial Day, but this really needs to be delayed until further information is given.

The city has Vilas Park and Wingra for boat rentals (probably no more than a mile away)

I stopped by the swimhouse and noticed a disgracefully large dock being built that is probably against any code out there. Just curious has the DNR and other regulatory bodies looked at that? I am concerned about fish habitat, their spawning areas, increased litter from snacks sold etc. into the waterway.

I cannot attend Wednesday's meeting, but I object. Please make this email part of the record - I am sharing it with my neighbors too.

Wingra Boats works on lake Wingra because it is a non-motorized lake.

67 non-motorized rentals WILL interfere with motorized boats and it presents a huge safety concern.

Those of us that live on the Bay and own boats often can't get under the bridges (when water levels are high) and are therefore FORCED to operate our boats in the Bay.

I pay almost 11K a year in property taxes - because I am presumably allowed to operate my motorized boat in the Bay. My taxes would not be as high if you put my house in Fitchburg or Verona, or anywhere in the city not on water.

Boating safety is the responsibility of all boaters - we need to be aware of our surroundings and act responsibility when we encounter sometimes crowded peak time conditions on an urban lake.
