- B. The signable area for a wall sign is determined by the areas of the facade of the building this is free of doors, windows or other major architectural detail, and that extends no higher than the juncture of the wall and the roof...
- C. Projecting signs may be displayed in addition to any wall signs allowed under Sec.31.07.


# III. REQUEST FOR FINAL APPROVAL TO AMEND AN EXISTING PD-SIP FOR AN EXCEPTION TO ALLOW FOR TWO SIGNABLE AREAS ON ONE FAÇADE.

- A. Allow for The Kitchen Gallery to use two signable areas on one façade, separated by architectural detail. Both facades are part of The Kitchen Gallery's leased space. The original building architecture was intended for two separate tenant spaces.
- B. The building is zoned commercial and approval of our request would allow for The Kitchen Gallery signage to be similar in nature to comparable areas in the downtown district.
- C. We believe our request maintains the integrity of the architecture.


