Speaking Engagements

September 14th – I spoke on a panel at the first Portland OR street food conference, continuing to make more nationwide contacts. Two of the speakers had been fellow

speakers of mine at the second San Francisco street food conference in 2011. Afterwards, we were treated to a free meal and drinks at one of Portland's food "pods", an arrangement that is the complete opposite of Madison. Portland food vendors may only operate on private property and do not have to move from their sites. Alcohol may be served in the pods. Madison vendors may only operate on public property and must move into and out of their sites every day.
