We met with Alders Sue Ellingson, and Ledell Zellers yesterday and received approval to host the event in the Olin Park area. While meeting with Dave from Intellasound and a lot of discussion, we all felt that using the south parking lot for the post-race festivities was best. We do not plan to use the soccer field for any part of the event. All parts of the event will take place on paved streets or parking lots. We will be submitting the Streets Use Permit based on following:

- We have chosen the Olin Park and John Nolen route as we feel it is far less disruptive than many other routes in the city. It has a minimal closures both in duration and streets/intersections affected. It does not affect Metro in any way.
- Registration would use the Pavilion
- Pre/Post race festivities would use the south parking lot of Olin Park
- Start/Finish would be on Olin Turville Ct.
- Request to close John Nolen from Olin to North Shore (Only Northbound Lanes) from 8:00pm to 10:00pm – 2 hours.
- We will set up a detour sending vehicles West on Olin, North on Park, East on West Washington, East on Proudfit and East on North Shore. Lakeside will be the only street affected for the 2 hour duration.
- We would keep an open lane at all times for boat traffic
- We would keep an open lane at all times in case an emergency vehicle would need to get through.

If at all possible, I would like to meet to discuss this prior to going to the Streets Use Meeting. I think a lot of the concerns have been addressed and with a thorough understanding of our process and what we have been able to do at other venues we can provide a decent case in which this plan will work and work well.

It is our intent to provide a great event with minimal disruption to all parties involved.

I will send in the Streets Use paperwork under a separate email. Please let me know if a meeting is possible.
