A. President's Report

B. Financial Report

Ms. Curliss reports that November was a good month and we are on track to meet year end goals.

a. Approval of 2014 OBS Budget

Ms. Sladky provided an overview of the OBS budget (the City of Madison was presented at the November meeting). The 2014 proposed budget is very flat when compared to the 2013 approved budget which was clearly express by charts. A chart also expressed the 2012 expenditures as provided by the 2012 audit – the most recently completed audit. Expenses are classed by the auditors as either Program Services (such as education, garden maintenance, events, newsletter, etc) and compared to Supporting Activities (fundraising and administration). In 2012, a 78/22 ratio was achieved which is desirable for a not-for-profit organization and is the goal for 2014.

A motion was made by Ms. Curliss and seconded by Ms. Ogden to approve the 2014 OBS Budget. Motion carried unanimously.

b. A motion was made by Ms. Ogden and seconded by Ms Loewi to transfer the \$200,000 received from the estate of Orville W Dusso to the Olbrich Botanical Society Foundation. The funds are donor-designated to benefit the Bolz Conservatory operations and will be placed in the Orchid Fund in the Foundation assets. Motion carried unanimously.
