The City of Madison is proposing to reconstruct portions of North Street, Hoard Street and Commercial Avenue in 2014. Proposed 2014 North St., Hoard St. and Commercial Ave. Reconstruction Project

Project Details - Proposed Work

Sanitary Sewer: Replace existing sanitary main (installed in 1921-1928) and replace laterals to the property line (assessable).

Water Main: Replace the existing water main (installed in 1911 to 1926) and reconnect services to the new main.

Storm Sewer: Replace as necessary, reconnect private storm sewer connections per City standards (*assessable*).

Street Reconstruction: All of the pavement and existing curb and driveway aprons within the project limits will be replaced. Sidewalk will be replaced on an as needed basis. The street widths are proposed to remain the same as existing. Several geometric changes are proposed to improve pedestrian access and safety and to improve access for motorists. The proposed changes include:

- The existing median on Commercial Ave. at Packers Ave. will be shorted to allow left-turns into and out of Dementral Field.
- Pedestrian islands will be added on North St. at the Hoard St. and Dayton St. intersections to improve pedestrian crossings.
- The intersection of East Dayton and North St. will be realigned to provide a standard intersection and the existing triangle island will be removed.
- The intersections of North St. with Hoard St., Upham St. and Mifflin St. will also be realigned slightly to improve visibility and provide shorter crossing distances for pedestrians.

Rain Gardens: Rain Gardens may be installed along the Hoard St. frontage of the project if requested by the property owner and if the terrace is deemed suitable for a rain garden by the City. If you live on Hoard St. and are interested in having a rain garden installed, please contact Corey Stelljes at 266-9721 by February 28, 2014.

Trees: Most existing trees will remain, but some removals of trees that are in poor condition will take place. Owners will be notified if there are tree removals in front of their property. Replanting of the trees will take place after completion of the project. All of the trees within the project limits will be pruned by City Forestry prior to the start of construction.

Construction Schedule & Impacts


Tentative Schedule: Mid-May, 2014 until October, 2014.

Traffic Impacts: Two-way traffic will be maintained on Commercial Ave. during the project. North St. and Hoard St. will be closed to through traffic during construction. Access will be maintained for emergency and local traffic. Pedestrian access will be maintained on at least one side of each of the streets at all times, and access to businesses will be coordinated as necessary. Bus routes will be maintained on Commercial Ave. Bus routes on North St. will be detoured.

Water Shut-offs: An average of two water shut-offs are expected for each property within the project limits, and the timing of these shut-offs will be coordinated as much as possible. A minimum of 48 hours of notice will be provided prior to the shut-offs. Each shut-off may last up to eight hours, but typically last about four hours.

At the start of construction, the existing main will remain in service until the new main is installed and connected to; emergency shut-offs may occur if the old, brittle main is damaged during construction.

Refuse Collection: It will be the contractor's responsibility to allow for refuse collection during construction. Please mark your address on your cart to make sure it is returned if moved. Please contact private collection companies to inform them of the project.
