Re: Point in Time Data

This year's PIT count took place on the night of January 29th. A breakfast was held on the morning of 1/30 at Bethel Lutheran Church in an effort to count any unsheltered homeless who were not counted the night before. All shelter and transitional housing programs participated by providing data on the persons sheltered/housed on that night. Beginning at 10:00 pm, 15 volunteers divided up the greater Madison area to count unsheltered persons primarily in places known to outreach workers, advocates, Madison police and Park Rangers. County JFF workers were contacted in an effort to count unsheltered homeless in their areas. Three Dane County school districts participated by providing information on unaccompanied youth.

This count is mandated by the US Department of Housing and Urban Development. In addition to counting those persons sheltered and unsheltered, an inventory of all housing units dedicated to serving homeless persons was conducted. There were 10 shelter programs reporting on 401 shelter beds (not including motel vouchers), 9 transitional housing programs reporting 275 units and 13 supported permanent housing programs reporting 1,015 beds. Of the transitional and supportive permanent housing units, 78 units are owned and operated by HSC agencies and an additional 271 units are rented from private landlords and provided rental subsidies.

What you will find below are the results of the January 29th Point In Time count of shelter and unsheltered persons in Dane County and the results of the previous year's PIT count for comparison.

When comparing the 1/2014 PIT with 1/2013 PIT, you will find:

- The number of individuals in families with children has decreased slightly for those sheltered and those unsheltered (1 less family sheltered and 2 fewer families unsheltered);
- The number of single adults decreased (27 fewer sheltered and 3 fewer unsheltered); and
- The number of unaccompanied youth and minor parents continues to be very low on the night of the PIT as the tendency for youth is to "couch surf" which is not included in HUD's definition of homelessness.

There were a total of 62 veterans identified – 51 veterans were sheltered while 11 veterans were unsheltered.

The number of homeless persons identified as chronically homeless is lower in 2014 than the previous year. However, the number of persons with mental health and alcohol/drug abuse issues increased.
