First, there seems to be a fair bit of ridership that boards on the stops within this loop with many people from the neighborhood using these stops to reach the UW campus and UW/VA hospital areas.	h -
	Second, if this loop is eliminated, residents of the Romnes Apartment complex at 540 W. Olin Ave will only have easy nearby access to Route 13 instead of easy nearby access to Routes 13 and 44. Many of these individuals are disabled so the impact might be more detrimental for these individuals than fully-abled individuals. Furthermore, Route 13 does not go to the UW/VA hospitals so Romnes Apartment residents won't be able to easily reach the hospitals via Metro without having to travel to Park Street to access the bus routes.	,

At its March 13, 2014 meeting, the Dunn's Marsh Neighborhood Council reviewed the proposed service modifications to Bus Route 59 in the City of Fitchburg. The Council unanimously approved the route change with one proposed modification. This is what we liked: • service to upper Allied Drive • an added stop on the Verona Frontage Road just before Allied Drive • an added stop further south on Allied Drive before the turn into Lovell Lane • service on Seminole Highway, Sentinel Pass, and Crescent Road • the loop in the commercial area near Aldi's, HyVee, and Target • service down Whitney Way to the West Transfer Point The proposed modification we discussed and would very much like to have is an added stop closer to Seminole Highway, at Sentinel Pass and Crescent Road. This would serve residents who live further east than the stop at Red Arrow Trail. There are a number of condos and a large number of apartment units on Crescent Road near this location as well as single family homes. At the time the Council discussed this route, we did not realize that the 59 is just a weekend route. We were discussing it as if it were a 7-day route. Had we realized, I am certain that the Council would have requested that the 59 become a daily route. There's a definite need for daily access to the health clubs near Executive Drive, the grocery stores near Target, as well as to the West Transfer Point. As you may know, the Dunn's Marsh Neighborhood is considered a "food desert" with no full-service grocery store within walking distance and only a few grocery items available at the Walgreen's drug store within the neighborhood. We also did not fully understand that the route is one-way in the Dunn's Marsh Neighborhood. This would apparently require a long trip or long waits for service to Executive Drive and McKee Road east of Verona Road. Having 2-way service through out the Dunn's Marsh Neighborhood, on Seminole Highway and McKee Road of Fitchburg west of Verona

I live in that residential area and find it to be very important for an elderly person like myself for getting to places like the VA and UW hospitals, to Agrace Hospice, and many other places.


