


## **Application for Change of Licensed Premise**

\$25 non-refundable filing fee is charged at time of application. Complete application is due at 12 noon two weeks before ALRC meeting. Applicants must appear before the ALRC.
Please contact City Zoning (MMB LL-100, 608-266-4560). A Conditional Use Permit may be required.
Detailed floor plans (no larger than 8 ½ x 14) must accompany this form, or the request will not be presented to the ALRC.  Orange sign- You must display the public notice sign within three days of your application at the current premise until the Common Council makes a final determination.
Prior to your appearance before the Alcohol License Review Committee (ALRC), you must contact  • The Alderperson of the District in which you intend to do business.  • The representative of the appropriate neighborhood association (if any).  • The Madison Police Department.
