Hi all,

Heather requested a brief summary of our past actions regarding the Middleton BBQ outdoor smoker. I've attached the complaint from last year. Our actions at that time were in regard to ensuring proper licensing was in place, the lack of a handwash station by the smoker, and referral of the complaint to zoning due to zoning restrictions for outdoor smoker use so close to residences. Brian of Middleton BBQ complied with orders to cease using the smoker in the parking lot at that time.

Middleton BBQ may use Buck's Pizza as a base (for food prep, storage, etc.) as long as Brian obtains proper temporary permitting and/or obtains a permanent food and drink license for catering. The prohibition for use of the smoker in the parking lot stems from the zoning regulations only. There are no air quality standards to provide a basis for enforcement.

I personally have not seen the smoker at Buck's Pizza since it came up last summer that use of the smoker was prohibited by zoning regulations. Beth Cleary stated she has driven past the restaurant on a few separate occasions too and has never seen it there. I have not received any other complaints besides the one from July and this current complaint. I performed the annual inspection for Buck's Pizza on 5/6/14 and was additionally there for follow up on 5/13/14 and 5/21/14. I did not see the smoker there during any of those visits.

If you have any questions, just let me know...with the caveat that I am on vacation Thursday the 5th through Monday the 9th so after this afternoon your best bet would be to contact Beth Cleary and/or Doug Voegeli.

Description of Complaint:

Caller states that there is guy that sets up a smoker in the parking lot of Buck's (she's noticed it on Saturdays) doing BBQ.

Her complaint is air quality as the smoker makes a lot of smoke and she lives in a nearby apartment. She has to close her windows.

She didn't see a name on the smoker so unknown if this is someone associated with Buck's or just someone who has gotten permission to use the lot. She says the smoker is not stored here. He pulls the smoker in behind his van on the weekend and takes it away when he is done.

Environmental Health Complaint Report

Onsite visit to establishment to inquire about meat smoking activities. Manager, Denise, did not know details but provided owner's phone number to contact. Left message for owner, Jed; received a call from Brian of Middleton BBQ Company. Brian stated he has been using Buck's as a commercial preparation space for temporary food permits he obtained through PHMDC. Brian stated he would park a mobile meat smoker in the parking lot and use the kitchen for preparation and utensil washing activities. He was there approximately every other weekend to smoke meat. Brian also stated he has been technically hired by Jed to smoke meat used on pizzas at the establishment. Discussed with Brian that there may be zoning regulations that prevent using the parking lot for smoking activities, and that additional licensing regulations may apply to using the meat in the restaurant. Informed Brian he would be contacted soon with further information.

CAZ - 07/24/2013 - Consultation

Email with Matt Tucker from zoning, who states that zoning code requires outdoor cooking to be conducted within completely enclosed buildings. He states he is not aware of any location within the City of Madison where an outdoor meat smoker would be allowed. Discussed situation with Beth Cleary. The Food Code does not allow use of portable meat smokers at licensed establishments. If the establishment desires to have smoked meat, it must have an indoor, commercial grade, approved smoker. The mobile meat smoker is only allowed for private parties and catering. Review of temporary permits for 2013 show that Middleton BBQ took out a total of 8 permits thus far, all of which have already occurred (last event was 7/23/13). Discussion with Eric Olson of built environment team regarding air quality concerns of complainant. He stated there are no regulations relating to air quality that would prevent the use of an outdoor meat smoker. Beth Cleary concurred.

CAZ - 07/25/2013 - Consultation

Phone conversation with Brian, operator of Middleton BBQ. Informed him that zoning regulations prohibit use of the meat smoker in the parking lot of establishment. A new location for meat to be smoked must be located outside of the City of Madison. Operator still to use establishment for prep and utensil washing before/after meat smoking process. Informed Brian that operator of Buck's Pizza, Jed, is not allowed to consider Brian his employee and conduct meat smoking in the parking lot, as this is outdoor cooking and in addition to zoning regulations that prohibit the activity, health department codes prohibit a permanent, licensed facility from performing outdoor cooking without prior approval. A second phone call with Brian and licensing supervisor Beth Cleary was conducted in which all of the above was reiterated. Becoming licensed as a caterer and/or via DATCP as a meat processor/wholesaler was discussed. Appointment set for the morning of Monday, 7/29/13, to meet at establishment and review remaining product used by Buck's Pizza. Email sent to Brian with PHMDC licensing information, DATCP contact information, a copy of Matt Tucker's email, and a copy of PHMDC outdoor cooking requirements fact sheet.

CAZ - 07/29/2013 - Issued Orders - No RI Required

Onsite visit to establishment to meet with Brian of Middleton BBQ and Jed of Buck's Pizza. Discussed prohibition of use of outdoor smoker due to city zoning regulations. If zoning were to approve use of outdoor smoker in parking lot, discussed outdoor cooking requirements for Buck's Pizza. Coyp of outdoor cooking fact sheet given to Jed. Approved handwashing would be one requirement. Discussed option of variance application if operators feel handwashing indoors is adequate for activities. Meat smoking may only occur with zoning's approval. Operators will be in contact if zoning approval is granted about outdoor cooking requirements.
