State Street Sidewalk Space Discussion with Madison Metro

Metro’s Tim Sobota and I spoke about the distance of State Street sidewalk cafes from the edge of the curb. Although law had long required a minimum distance of two feet, Tim was in favor of using the sidewalk crease that was 2.5 feet from the curb. He felt that it was as a safer place for pedestrians to stand as vehicles were passing in the street, including busses. He also felt that the 2.5 distance should be maintained on every block of State Street. He added that it would be ideal from Metro’s point of view to have any sidewalk cafes near bus stops be inset at a distance that matched the street-side plane of the bus stop structure.
