Dear Mr. Adams;

Your one-lot certified survey of property located at 601 Langdon Street, Section 14, Township 7N, Range 9E, City of Madison, Dane County, Wisconsin, is hereby **conditionally approved**. The property is zoned PD (Planned Development District). The conditions of approval from the reviewing agencies to be satisfied prior to final approval and recording of the CSM are:

Please contact Janet Schmidt of the City Engineering Division at 261-9688 if you have questions regarding the following nine (9) items:

- 1. Remove Notes 1, 2 and 6 on Sheet 2 from the Certified Survey Map (CSM).
- 2. Street name is "N. Frances Street". Add the pre-directional to the street name.
- 3. Elevations shall be referenced to NAVD of 1988 per City of Madison Published Control.
- 4. Remove Note 5 on Sheet 2. There are not any Public Utility Easements being granted by this CSM.
- 5. Add "thence" to the beginning and "along the south line of the said Southwest Quarter" to the end of the first course of the legal description under the Surveyor's Certificate.
- 6. Add adjoiner calls to all sides of the boundary of the Certified Survey Map in the legal description under the Surveyor's Certificate.
- 7. Graduate Madison Owner, LLC is a Delaware Limited Liability Company. Modify the Owner's Certificate as necessary to acknowledge this.
- 8. The following note shall be placed on the CSM: "No changes in drainage patterns associated with development on any or all lots within this CSM shall be allowed without prior approval of the City Engineer."

9. Wisconsin Administrative Code A-E 7.08 identifies when Public Land System (PLS) tie sheets must be filed with the Dane County Surveyor's office. The developer's surveyor and/or applicant must submit copies of required tie sheets or condition reports for all monuments, including center of sections of record, used in this survey, to Eric Pederson, City Engineering Division. If a new tie sheet is not required under A-E 7.08, Engineering requests a copy of the latest tie sheet on record with Dane County Surveyor's office. The applicant shall identify monument types on all PLS corners included on the plat or CSM. Note: Land tie to two PLS corners required.

Please contact Dennis Cawley of the Madison Water Utility at 261-9243 if you have any questions regarding the following item:

10. Note: All operating private wells shall be identified and permitted by the Madison Water Utility and all unused private wells shall be abandoned in accordance with MGO Sec. 13.21.

Please contact Bill Sullivan of the Madison Fire Department at 261-9658 if you have any questions regarding the following item:

11. Note: The Madison Fire Department does not object to this proposal provided the project complies with all applicable fire codes and ordinances.

Please contact Jenny Frese of the Office of Real Estate Services at 267-8719 if you have any questions regarding the following four (4) items:

- 12. Prior to requesting final sign-off, executed signature block certifications shall be included for all parties of interest, pursuant to Wis. Stats. 236.21(2)(a). All signatory parties shall provide documentation that proves said signatories have legal authority to sign the Owner's Certificate. The owner's name shall be added to the certificate to reflect ownership reported in the most recent title report and the notary block shall contain the correct county and state.
- 13. Under 236.21(3) Wis. Stats. and MGO Section 16.23(5)(g)(1), the property owner shall pay all real estate taxes and special assessments that are accrued or delinquent for the subject property prior to CSM recording. The 2013 real estate taxes are paid for the subject property and there are no special assessments owed.
- 14. Prior to final CSM sign-off, please verify with Janet Schmidt of the City Engineering Division (261-9688) or Sharon Pounders at the Water Utility (266-4641) that stormwater management fees are paid in full.
- 15. Revise the CSM prior to final sign-off as follows: All ownership consents and certifications for the subject lands shall conform to Wis. Stats. 236.21(2) and 236.29 by including the language "...surveyed, divided, mapped and <u>dedicated</u>..."

Note: This letter pertains to the proposed lot combination CSM needed for Building Code purposes and not to the PD-SIP alteration for the hotel to create a top floor restaurant and outdoor eating area. The conditions of approval for that request will be sent separately following Plan Commission action.

Specific questions regarding the comments or conditions contained in this letter should be directed to the commenting agency.

A resolution approving the CSM and authorizing the City to sign it and any other documents related to the proposed land division was approved by the Common Council on <u>September 16</u>, <u>2014</u>.

As soon as the comments and conditions have been satisfied as verified with a completed affidavit form (attached), the original along with the revised Certified Survey Map, with all signatures and approvals from the reviewing agencies, shall be brought to this office for final signoff. You or your client may then record the certified survey at the Dane County Register of Deeds. For information on recording procedures and fees, contact the Register of Deeds at 266-4141.

Prior to City Engineering final sign-off by the main office of the CSM, the final CSM shall be submitted to the Engineering Division Surveyor/ Land Records Coordinator for final technical review and approval. This submittal must occur a minimum of two working days prior to final Engineering Division signoff. Email submittal of the final CSM in PDF form is preferred. Transmit to <a href="mailto:jrquamme@cityofmadison.com">jrquamme@cityofmadison.com</a>.

The owner shall furnish to the Office of Real Estate Services and the survey firm preparing the CSM an updated title report covering the period between the date of the initial title report and the date when final signoff is requested. The surveyor shall update the CSM with the most recent information reported in the title update.

Upon acceptance and recording of the Certified Survey Map by the Dane County Register of Deeds, please transfer the recorded volume, document number, and page numbers to the copies and forward a copy to this office for our records. The original survey map with the recording information is permanently kept on file in the Dane County Register of Deeds Office. A copy of the recorded document can be obtained from the Register of Deeds Office, Room 110, City-County Building or the Real Estate Office in the Madison Department of Planning and Development.

Any appeal from this action, including the conditions of approval, must be filed with the Circuit Court within 30 days from the date of this letter. The approval of this CSM shall be null and void if not recorded in twelve (12) months from the date of the approving resolution or this letter, whichever is later.
