The Johnson Bend project has not changed since our meetings ended in May of 2014. We made all the recommended changes by the neighborhood. The exterior of the building is the same. We had looked into conventional parking but went back to mechanical parking, the same as when we submitted to the neighborhood last winter.

I was unaware of the request by Alderman Verveer for a status update meeting with the neighborhood committee on the project until one hour ago. We have been delayed several times in the last two months on getting our approvals by city staff trying to workout planning and traffic and engineering questions that came up due to the mechanical parking. An independent study was done and city staff now supports the project. With the delays, we nearly lost our financing several times in the last month and a half. My financing is subject to the city's approval. It is imperative to seek approvals tonight, otherwise, I will lose my financing and the project is dead.
