Proposed 2015 Bluff St/Kendall Ave Utility Replacement with Street Resurfacing Project

Project Details – Proposed Work

Water Main: Replace the existing 6” cast iron water main (installed in 1960) and reconnect services to the new main.

Sanitary Sewer: Minor sanitary sewer extension near N Franklin Street for future property service (*assessable*).

Storm Sewer: New storm sewer will be installed from N Blackhawk Road to Palomino Lane.

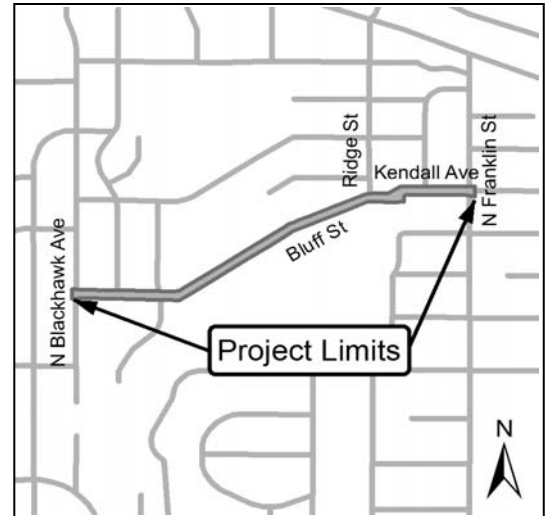
Street: Replace the pavement and replace the existing curb, driveway aprons, and sidewalk (*assessable*) as needed.

Trees: The trees within the project limits that will remain will be pruned by City Forestry prior to the start of construction. There are 7 trees identified for removal:

3410 Bluff Street	3006 Bluff Street
401 Ridge Street (2 trees)	2825 Kendall Avenue
314 Shepard Terrace	3305 Bluff Street

Metro Bus: Proposed bus detour for eastbound service. Westbound buses remaining on Bluff St/Kendall Ave.

Construction Schedule & Impacts

Tentative Schedule: May 2015 to July 2015

Traffic Impacts: Westbound traffic will be maintained. Access will be maintained to driveways unless work is directly in front of driveway.

Parking on the street will be allowed from 7:00pm to 7:00am during the weekday.

Water Shut-offs: An average of two water shut-offs are expected for each property within the project limits, and the timing of these shut-offs will be coordinated as much as possible. A minimum of 48 hours of notice will be provided prior to the shut-offs. Each shut-off may last up to 8 hours, but typically last about 4 hours.

At the start of construction, the existing main will remain in service until the new main is installed and connected to; emergency shut-offs may occur if the old, brittle main is damaged during construction.

Refuse Collection: It will be the contractor’s responsibility to allow for refuse collection during construction. Please mark your address on your cart to make sure it is returned if moved. Please contact private collection companies to inform them of the project.
