

Key Goals

- Document the blueprint, which would include a violence reduction plan
- Assist with gaining community input and buy-in into the blueprint
- Develop action strategies around the blue print which will include input through a 5-sector collaboration strategy
- Develop a communications strategy focused on uplifting progress made but also focuses on identifying and tackling obstacle
 - Communications strategy would include two strands
 - Mayor to key stakeholder group, e.g. philanthropy, business, etc.
 - 5 sector communications (integrated conversations with all sectors at the table)

- Help Madison broker access to leaders from federal and local agencies, philanthropic organizations, and community based organizations
