The City of Madison Board of Public Works will hold a public hearing on the issue of allowing construction activities, with associated noise impacts, outside the period of 7:00 AM to 7:00 PM for certain work items just west of the intersection of West Lakeside Street and Lake Court. The Public Hearing will be on July 22nd, 2015 at 5:00 PM at the City of Madison, City-County Building Room 108, 210 Martin Luther King Jr. Blvd.

Madison General Ordinance section 24.08(3) provides the Common Council the ability to allow construction activities outside of the hours of 7:00 AM to 7:00 PM, with the passage of a resolution and a hearing before the Board of Public Works.

The City sanitary sewer is scheduled to be repaired on West Lakeside Street just east of Lake Court. The work is scheduled to begin August 5th and last one week. This work is necessary because the sanitary sewer was found to be in disrepair during routine maintenance. The construction repair work will be done during the daytime hours, but with sewer being located in an area where there is a high groundwater table, we are expecting to have a generator running during the night time hours to supply power to the pump. This sewer repair work will be completed by City crews.


