Madhatters 322 W. Gorham Street Madison, WI 53703

On or about August 6, 2015 Ted Gervasi, as agent for B.A.T., Inc., pled "no contest" to Eighteen counts in a thirty-one (31) count complaint filed in Madison Municipal Court. Thirteen counts were dismissed pursuant to routine case settlement negotiations.

The Madhatters convictions span eight (8) different dates and in some cases there are multiple violations occurring on the same date in the course of one incident. Madison General Ordinance Sec. 38.10(4)(d) states that demerit points may not be assessed for multiple ordinance and/or statute violations resulting from a single incident. In these cases, the penalty shall be based only upon the violation that carries the higher demerit point assessment.

I have amended the layout of the report dated August 19, 2015 in an attempt to make it clear what the maximum point violation is per incident.

On September 6, 2013, Madison Police Officers counted 256 people on the second floor of Madhatters and found the first floor to be at legal capacity. The lawful capacity for the second floor is 150. Madhatters was **70% over lawful capacity** on September 6, 2013.

On August 22, 2014, Madison Police officers counted 258 people on the second floor and found first floor to be at capacity. Madhatters was **72% over lawful capacity** on August 22, 2014.
