Title

Creating Sections 2.40(4)(h) and 3.30(4) of the Madison General Ordinances to prohibit a person who is registered as a lobbyist under City Ordinances from serving as a member of any permanent or temporary City board, commission or committee.

Body

DRAFTER'S ANALYSIS: This proposal would prohibit a person who is registered as a lobbyist under City Ordinances from serving as a member of any permanent or temporary City board, commission or committee.

The Common Council of the City of Madison do hereby ordain as follows:

1. Subdivision (h) of Subsection (4) entitled "Prohibited Practices" of Section 2.40 entitled "Lobbying Regulated" of the Madison General Ordinances is created to read as follows:
 "(h) No lobbyist may serve as a member of any ad hoc or standing sub-unit, including, but not limited to, any City board, committee, commission, task force or similar body."
2. Subsection (4) of Section 3.30 entitled "Qualifications--City Officers, Members of Commissions, and Employees" of the Madison General Ordinances is created to read as follows:
 "(4) Lobbyists: Boards, Commissions and Committees. No person who is registered as a lobbyist, pursuant to Sec. 2.40 MGO, may serve as a member of any ad hoc or standing sub-unit, including, but not limited to, any City board, committee, commission, task force or similar body. In the event that any person who is a member of any ad-hoc or standing subunit registers as a lobbyist pursuant to Sec. 2.40 his or her position shall be deemed vacated. Such vacancy shall be filled in the manner prescribed by law or ordinance for the original appointment of that position."
