Re: Proposed Street Reconstruction Project & Public Hearing

The City of Madison is proposing to resurface a portion of S. Gammon Rd. and reconstruct a portion of McKenna Blvd. in 2016. Enclosed with this letter is a fact sheet with some details on the proposed project, which includes a map of the proposed project limits. Also enclosed is a notification for the Public Hearing before the Board of Public Works. The date, time and location of the public hearing can be found on the notification.

This project will involve special assessments to the owners of property adjacent to the project. The property owners will be assessed for various items included with this proposed project, and the costs of some of those items are assessed entirely to the owner. A table detailing the City's standard assessment policy for the items of work is included on the fact sheet.

Also enclosed is a Schedule of Assessments, which shows the estimated costs for each property adjacent to the project. After the work is complete, a final assessment will be calculated based on bid prices and work actually performed. The final assessment, which will be billed after the completion of the project, is payable in one lump sum or over a period of 8 years, with 3% interest charged on the unpaid balance.

Several properties, namely some individual condos, have an estimated assessment of less than \$5.00. Pursuant to City policy, the City will not levy any assessments under \$5 to the property; therefore, any properties with an estimated assessment of less than \$5.00 have been removed from the schedule of assessments and will not receive a hard copy of the schedule of assessments with this mailing.

To request accommodations for special needs or disabilities or if you have any other questions regarding this project, please contact the Project Engineer. This includes requests relating to the Public Hearing and also requests relating to the actual operations of construction. A list of contacts for this project can be found on the enclosed fact sheet.

Fact and Details Sheet

Proposed 2016 Gammon Rd. Resurfacing & McKenna Blvd. Improvement Project

Project Details – Proposed Work (See reverse for project location map)

Street: The pavement will be resurfaced on S. Gammon Rd. from just north of Schroeder Rd. to south of Morraine View Dr. by grinding off the top 3" of asphalt and replacing it with new surface. The curb and sidewalk will be replaced as needed to repair damaged or offset sections (assessable). Also, the traffic islands at Morraine View Dr. will be made larger to provide a better pedestrian refuge, and the roadway will be flared out around the islands to provide adequate widths for the bike lanes and travel lanes.

To improve pedestrian, bike and vehicle safety along McKenna Blvd., a new median will be installed from just west of Gammon Ln. through Hammersley Rd. This will be accomplished by widening the roadway to the north. The new median will make the pedestrian crossings safer, and will allow for dedicated left turn lanes. Also, a bike lane will be added where it doesn't currently exist, and the bike lanes and travel lanes through this area will be installed at more standard widths as the existing lanes are quite narrow. New sidewalk will be installed on the south side of McKenna Blvd. (Elver Park) to connect the sidewalk at the park entrance with the existing sidewalk further south on McKenna near the Police station.

Sanitary Sewer: The existing sewer main is 8" PVC pipe, installed in the 1980's. Minimal, work on the sanitary sewer is expected.

Water Main: The size of the water main varies in the area of this project, but most of it was installed in the 1980's. However, there has been a history of breaks on the main in the area of Jacobs Way & Hammersley, so the water main in that area will be replaced.

Storm Sewer: Limited work on the storm sewer is expected on the Gammon Rd. portion of the project. On the McKenna portion, storm sewer inlets will be relocated with the street changes, and the culverts crossing under McKenna Blvd. at Elver Park will be extended as needed. Private storm sewer connections to the storm sewer main will be made as necessary (assessable).

Street Lights & Signals: Existing street lights and signals will be relocated and reinstalled with the street modifications along McKenna Blvd., and the pedestrian flashers at Morraine View will also be reinstalled. Based on public input and request, the intersection of New Washburn Way and S. Gammon Rd. has been added to City's process for potential new traffic signals. Information on this process can be found here: www.cityofmadison.com/trafficEngineering/criteriaTrafficSignals.cfm

Trees: There are several planned tree removals with this project. A list of locations of removals is on the reverse of this sheet. If any other trees must be removed, the adjacent properties will be notified prior to removal. Trees within the project limits that are to remain will be pruned by City Forestry prior to the start of construction. After the project, the site will be reviewed to replace removed trees and for possible new plantings.

Construction Schedule & Impacts

Tentative Construction Schedule: April 6, 2016 until End of July, 2016

This proposed project is scheduled to be advertised for bids on Dec. 23, 2015.

Traffic Impacts: During construction, Gammon Rd. and McKenna Blvd. will be reduced to a single travel lane in either direction. Access at intersections, to driveways, and to Elver Park will be provided, except when work is taking place immediately in that location. It is expected that there will some traffic delays as a result of the lane reduction. City Engineer & Metro are coordinating to provide bus service during construction, but this may involve an alternate route.

Water Shut-offs: In the area of the water main replacement, an average of two water shut-offs are expected for each property in that area. A minimum of 48 hours of notice will be provided prior to the shut-offs. Each shut-off may last up to 8 hours, but typically lasts about 4 hours.

At the start of construction, the existing main will remain in service until the new main is installed and connected to; emergency shut-offs may occur if the old, brittle main is damaged during construction.

Mail & Refuse Collection: It will be the contractor's responsibility to allow for mail delivery and refuse collection during construction. Please mark your address on your refuse cart to make sure it is returned if moved. Also, City Streets will collect in the construction area first thing in the morning, so please have your carts out before 7AM.

Landscaping: Any existing landscaping near or within the right-of-way will likely be removed during construction. If you wish to save any of that landscaping, it should be removed prior to the start of work. Contact the project engineer with questions regarding the limits of the work.


